OPINION AND ORDER

The Union Ice Company, a corporation, by these petitions, seeks to establish a truckload exception rating of Class 35.4, minimum weight 40,000 pounds, on ice, in blocks, effective January 1, 1971. The present exception rating of Class 35.4, minimum weight 30,000 pounds, is scheduled to expire with December 31, 1970.

Petitioner states that it manufactures ice at various locations including Salinas, Watsonville and Firebaugh and that it furnishes large quantities of ice during the summer harvesting season for the icing of rail cars, which are loaded with melons for transportation beyond the rail-heads to various points in the East.

Petitioner declares that, during the harvesting season, the needed volume of ice far exceeds the capacity of its ice manufacturing facilities at Firebaugh and other San Joaquin Valley points. Petitioner asserts that it has supplemented these facilities for many years by transporting ice and having ice transported from its plants at Salinas and Watsonville to Firebaugh, Huron and other points in the San Joaquin Valley where the rail cars have been loaded.

Petitioner contends that, should the current truckload exception rating on ice expire with December 31, 1970, and the higher truckload classification rating be applied to the transportation in question after that date, large percentage increases in charges would be incurred by it and other shippers. Petitioner states that ice is an extremely cheap commodity which sells at prices approximating \$7.50 to \$9.00 per ton and that it is already bearing a very high transportation cost. Petitioner avers that, unless rates are retained at a level comparable to that now prevailing, ice will no longer be transported by for-hire motor carriers. Petitioner alleges that it operates some trucks and will extend its proprietary operations, if necessary to enable its product to continue to compete with mechanical refrigeration.

Item 101600 of National Motor Freight Classification A-11 sets forth a truckload rating of Class 35, minimum weight 40,000 pounds.

²Petitioner cites the current rate, exclusive of the applicable surcharges, of 29 cents per 100 pounds for a typical haul from Salinas to Firebaugh. The rate for this movement under the higher truckload classification rating would be 42½ cents per 100 pounds, exclusive of the applicable surcharges. The resulting increase, exclusive of the surcharges, would be 46½ percent.

The certificate of service shows that copies of the petitions were mailed to California Trucking Association on April 7, 1970. The petitions were listed on the Commission's Daily Calendar of April 14, 1970. No objection to the granting of the petitions has been received.

The Transportation Division staff has reviewed the petitions and recommends that they be granted by an ex parte order.

In the circumstances, it appears, and the Commission finds that the proposed truckload exception rating of Class 35.4, minimum weight 40,000 pounds, on ice, in blocks, is reasonable and the resulting minimum rates will be just, reasonable and nondiscriminatory minimum rates for the transportation involved. A public hearing is not necessary. The Commission concludes that the petitions should be granted.

IT IS ORDERED that:

- 1. Exception Ratings Tariff No. 1 (Appendix A to Decision No. 66195, as amended) is hereby further amended by incorporating therein, to become effective January 1, 1971, Twenty-third Revised Page 3 and Second Revised Page 27-WWW, attached hereto and by this reference made a part hereof.
- 2. Tariff publications authorized to be made by common carriers as a result of the order herein shall be filed not earlier than the effective date of this order and may be made effective not earlier than January 1, 1971, and may be made effective on not less than ten days' notice to the Commission and to the public if filed not later than sixty days after the effective date of the minimum rate tariff pages incorporated in this order.

- 3. Common carriers, in establishing and maintaining the rating authorized hereinabove, are hereby authorized to depart from the provisions of Section 460 of the Public Utilities Code to the extent necessary to adjust long- and short-haul departures now maintained under outstanding authorizations; such outstanding authorizations are hereby modified only to the extent necessary to comply with this order; and schedules containing the rating published under this authority shall make reference to the prior orders authorizing long- and short-haul departures and to this order.
- 4. In all other respects, Decision No. 66195, as amended, shall remain in full force and effect.

The effective date of this order shall be twenty-four days after the date hereof.
