# <u>O P I N I O N</u>

Certified Freight Lines, Inc. requests authority to sell and transfer, and City Transfer, Inc. requests authority to purchase and acquire, certain certificated rights authorizing operations as a highway common carrier. The transfer is subject to the jurisdiction of the Interstate Commerce Commission pursuant to Section 5 of the Interstate Commerce Act. On July 8, 1970, the Interstate Commerce Commission authorized the transfer subject to the approval of this Commission.

The certificated authority was granted by Decision No. 62940 as amended by Decision No. 66481 and authorizes the transportation of general commodities between various points within the State. Said certificate also authorizes the transportation of fresh fruits and vegetables, which is not subject to the sale, and will be retained by applicant seller. The agreed cash consideration is \$60,000, which also includes the transfer of corresponding interstate authority.

Applicant purchaser is presently engaged in the transportation of general commodities between points in the Los Angeles Basin area on shipments moving in both intrastate and interstate commerce.

After consideration the Commission finds that the proposed transfer would not be adverse to the public interest. A public hearing is not necessary. The order which follows will provide for, in the event the transfer is consummated, the revocation of the certificates presently held by Certified Freight Lines, Inc. and City Transfer, Inc. and the issuance of certificates in appendix form restating the operating authorities of said carriers.

Certified Freight Lines, Inc. and City Transfer, Inc. are hereby placed on notice that operative rights, as such, do not constitute a class of property which may be capitalized or used as an element of value in rate fixing for any amount of money in excess of that originally paid to the State as the consideration for the grant of such rights. Aside from their purely permissive aspect, such rights extend to the holder a full or partial monopoly of a class of business over a particular route. This monopoly feature may be modified or canceled at any time by the State, which is not in any respect limited as to the number of rights which may be given.

The authorization herein granted shall not be construed as a finding of the value of the rights and properties herein authorized to be transferred.

# ORDER

IT IS ORDERED that:

1. On or before December 1, 1970, Certified Freight Lines, Inc. may sell and transfer, and City Transfer, Inc. may purchase and acquire, the operative rights referred to in the application.

2. Within thirty days after the consummation of the transfer herein authorized, purchaser shall notify the Commission, in writing, of that fact and within said period shall file with the Commission a true copy of any bill of sale or other instrument of transfer which may be executed to effect said transfer.

3. Purchaser shall amend or reissue the tariffs on file with the Commission, naming rates and rules governing the common carrier operations herein to show that it has adopted or established, as its own, said rates and rules. The tariff filings shall be made effective not earlier than five days after the effective date of this order on not less than five days' notice to the Commission and the public, and the effective date of the tariff filings shall be concurrent with the consummation of the transfer herein authorized. The tariff filings made pursuant to this order shall comply in all respects with the regulations governing the construction and filing of tariffs set forth in the Commission's General Order No. 80-A. Failure to comply with and observe the provisions of General Order No. 80-A may result in a cancellation of the operating authority granted by this decision.

4. In the event the transfer authorized in paragraph 1 hereof is consummated, certificates of public convenience and necessity are granted to Certified Freight Lines, Inc. and City Transfer, Inc.

5. The certificates of public convenience and necessity granted in paragraph 4 of this order shall supersede the certificates of public convenience and necessity granted by Decision No. 62940, as amended by Decisions Nos. 66481 and 67657, and Decision No. 59618, as amended by Decision No. 63829, which certificates are revoked effective concurrently with the effective date of the tariff filings required by paragraph 3 hereof.

6. Within thirty days after the effective date hereof, applicants shall file a written acceptance of the certificates herein granted. Applicants are place on notice that, if they accept the certificates of public convenience and necessity herein granted, they will be required, among other things, to comply with and observe the safety rules of the California Highway Patrol and the insurance requirements of the Commission's General Order No. 100-F.

7. Applicants shall maintain their accounting records on a calendar year basis in conformance with the applicable Uniform System of Accounts or Chart of Accounts as prescribed or adopted by this Commission and shall file with the Commission, on or before March 31 of each year, an annual report of their operations in such form, content, and number of copies as the Commission, from time to time, shall prescribe.

If applicants elect not to transport collect on delivery shipments, they shall make the appropriate tariff filings as required by the General Order.
