## SUPPLEMENTAL ORDER

Ordering paragraph 4 of Decision No. 55843, dated November 19, 1957, provides "That the Smithson Springs Water Company shall be restricted to furnishing water service within its presently authorized service area boundaries only, except as provided in this decision and in Decision No. 54551."

Decision No. 56884, dated June 24, 1958, authorized that certain additional water service be provided by Smithson Springs Water Company and affirmed the other provisions of Decision No. 55843. Subsequent orders of the Commission have continued the restriction as to extension of service outside of the authorized service area of the Smithson Springs Water Company.

By letter dated August 4, 1970, the utility requested authority to provide water service on a surplus basis to the

residence of Mrs. Kathryn Hand (a single family dwelling) and not more than 2,000 square feet of land adjacent to this residence, which is located on a parcel adjacent to its service area.

The utility states that the residence of Mrs. Hand had been supplied water for approximately two years when the present management assumed control of the water company. The utility alleges that such service at this time would not impose demands exceeding the requirements of the existing customers of its service area; however, such service on a surplus basis would be terminated if the water supply is required for use within its service area.

The Commission finds that such service on a surplus basis would not be advance to the public interest and concludes that the request should be granted; therefore,

IT IS ORDERED that Smithson Springs Water Company, Inc., is authorized to render water service to the residence of Mrs. Kathryn Hand and not more than 2,000 square feet of land adjacent to this residence located approximately 200 feet northwest of the corner of Mesquite Road and Spring Road, Pinon Hills, provided, however, that such service shall be subject to termination in the event of a shortage in its water supply.

In all other respects, Decision No. 55843, as modified by Decision No. 56884, shall remain in full force and effect.

The effective date of this order shall be the date hereof.
