## SUPPLEMENTAL OPINION AND ORDER

By Decision No. \_\_\_\_\_\_, entered today in Case No. 5432, et al., the Commission authorized National Motor Freight Traffic Association, Inc., Agent, to revise certain ratings and rules in National Motor Freight Classification A-11 and adopted such ratings and rules to govern various Commission minimum rate tariffs. The Commission concluded that Minimum Rate Tariffs Nos. 2 and 5 and Exception Ratings Tariff No. 1 should be amended to reflect changes in item number references in such tariffs to commodity descriptions in the above classification and that the necessary amendment in Minimum Rate Tariff No. 5 should be made by separate order to avoid duplication of tariff distribution.

IT IT ORDERED that:

1. Minimum Rate Tariff No. 5 (Appendix A of Decision No. 32504, as amended) is hereby further amended by incorporating therein, to become effective October 15, 1970, Third Revised Page 22-D attached hereto and by this reference made a part hereof.

2. Common carriers subject to the Public Utilities Act, to the extent that they are subject also to Decision No. 32504, as amended, are hereby directed to establish in their tariffs the amendments necessary to conform with the further adjustments ordered herein. C. 5435 (Pet. 157) - bjs

3. Tariff publications required to be made by common carriers as a result of the order herein shall be made effective October 15, 1970, on not less than two days' notice to the Commission and to the public and tariff publications which are authorized but not required to be made by common carriers as a result of the order herein may be made effective not earlier than October 15, 1970, and may be made effective on not less than two days' notice to the Commission and to the public if filed not later than December 14, 1970.

4. Common carriers, in establishing and maintaining the amendment authorized hereinabove, are hereby authorized to depart from the provisions of Section 460 of the Public Utilities Code to the extent necessary to adjust long- and short-haul departures now maintained under outstanding authorizations; such outstanding authorizations are hereby modified only to the extent necessary to comply with this order; and schedules containing the amendment published under this authority shall make reference to the prior orders authorizing long- and short-haul departures and to this order.

5. In all other respects Decision No. 32504, as amended, shall remain in full force and effect.

The effective date of this order shall be twenty days after the date hereof.
