ORDER REVOKING OPERATIVE AUTHORITY

By Decision No. 73678 dated January 30, 1968, in Application No. 49561, Richard A. Allen, Donald A. Moore, Fred H. Van Tassell and Robert E. Loveday, doing business as Mercury Sedan Service, were granted a passenger stage operative right authorizing service between various points in Alameda, San Mateo and Santa Clara counties, on the one hand, and the San Francisco International Airport, the Oakland International Airport and the San Jose Municipal Airport, on the other hand. During the month of March 1969, Richard A. Allen, Donald A. Moore, Fred H. Van Tassell and Robert E. Loveday, without appropriate authority, discontinued the passenger stage service theretofore conducted by them between the aforementioned points pursuant to the foregoing described operative right, and that by letter dated August 7, 1970, Richard A. Allen, one of the partners, requested that the Commission defer any action toward revoking the certificate pending the possible sale of the business, including the transfer of operating rights; therefore.

(1) IT IS ORDERED that on November 30, 1970 the passenger stage operative rights, created by Decision No. 73678 in Application No. 49561, are hereby revoked and all effective tariffs and timetables on file with the Commission in the name of Richard A. Allen, Donald A. Moore, Fred H. Van Tassell and Robert E. Loveday, doing business as Mercury Sedan Service, are hereby canceled. In the event that application is filed with the Commission, prior to November 30, requesting authority to transfer these operating rights, this order will be stayed until further order of the Commission.

(2) IT IS FURTHER ORDERED that the operative rights described in ordering paragraph 1, are hereby suspended.

The Secretary is directed to mail a certified copy of this order to Richard A. Allen, Donald A. Moore, Fred H. Van Tassell and Robert E. Loveday at 1630 Old Almaden Road, San Jose, CA 95125, last known address as shown in the Commission's records.

The effective date of this order shall be the 20th day after the above mailing to the above named parties unless, before such effective date, there shall have been filed with this Commission written response to this order requesting public hearing in which event the effective date of this order shall be stayed until further order of the Commission.
