SUPPLEMENTAL OPINION AND ORDER

Beers and Minnis, Inc., a corporation, possesses operative rights as a common carrier by vessel between points on San Francisco. Suisun and San Pablo Bays and the Sacramento and San Joaquin Rivers and their tributaries and as a highway common carrier between Colusa and Grimes.

William G. Minnis, Secretary of the corporation, has submitted to this Commission a certified copy of a Certificate of Amendment of Articles of Incorporation which has been filed with the Secretary of State changing the corporate name to "River Lines Company." Accordingly, the operative rights will be amended to show the new corporate name. The carrier will also be ordered to amend its tariff pursuant to General

Orders Nos. 80-A and 117. A public hearing is not necessary.

IT IS ORDERED that:

- 1. Decision No. 76032 dated August 19, 1969, in Application No. 51269 is amended by substituting therein "River Lines Company" in place and stead of "Beers and Minnis, Inc."
- 2. Appendix A of Decision No. 61732 is amended by incorporating therein First Revised Pages 1 and 2, attached hereto, in revision of Original Pages 1 and 2.
- 3. Within sixty days after the effective date hereof and on not less than five days' notice to the Commission and the public, River Lines Company shall amend its tariff on file with this Commission as required by Rules 6.4 and 6.2 of General Orders Nos. 80-A and 117, respectively.
- 4. In all other respects, Decision No. 76032 shall remain in full force and effect.

This order shall become effective twenty days after the date hereof.

 - b. Such commodities shall be tendered to the carrier at one of the warehouses of Sacramento River Warehouse Company located on the Sacramento River at Colusa.
 - c. The transportation by highway common carrier may be performed as a substitute service for water carrier service from Colusa to Grimes at carrier's option.
 - d. The highway common carrier service from Colusa to Grimes shall be performed only when in connection with a subsequent movement by water from Grimes to destination.
- (3) Service pursuant to the authority described in paragraphs (1) and (2) hereof shall be conducted over and along State
