## OPDER OF REVOCATION

Kiyoshi Nobusada, Kenneth H. Sato and Rinzi Manaka, a copartnership, doing business as Consolidated Factors, are the holders of a certificate of public convenience and necessity to operate as a highway common carrier as defined in Section 213 of the Public Utilities Code which authorizes the transportation of certain commodities between points in California.

The certificate was acquired by the partners pursuant to Decision No. 65712 dated July 1, 1963, in Application No. 44562 as modified by Decision No. 66262 dated November 5, 1963.

On October 21, 1970, Frank Loughran, attorney for the partners, submitted a request that the certificate be revoked.

The applicants' attorney indicated that there has existed no demand for this service for the past few years. He believes that there is no longer any need for this particular service.

In the circumstances, it appears, and the Commission finds, that the revocation of the certificate of public convenience and necessity as requested would not be adverse to the public interest. A public hearing is not necessary. The Commission concludes that the certificate should be revoked and the tariffs applicable to the service thereunder should be cancelled.

IT IS ORDERED that:

1. The certificate of public convenience and necessity to operate as a highway common carrier acquired by Kiyoshi Nobusada, Kenneth H. Sato and Rinzi Manaka, copartners, doing business as Consolidated Factors, by Decision No. 65712 dated July 1, 1963, in Application No. 44562 as modified by Decision No. 66262 dated November 5, 1963, is hereby revoked.

2. Consolidated Factors Local Freight Tariff No. 1, California Public Utilities Commission No. 1, is hereby cancelled.

3. Pacific Coast Tariff Bureau, C. R. Nickerson, Agent, is hereby authorized and directed to cancel the participation of Kiyoshi Nobusada, Kenneth H. Sato. and Rinzi Manaka from its tariffs on file with the Commission, such cancellation to be made within thirty days after the effective date of this order on not less than ten days' notice to the Commission and to the public.

4. The Secretary is directed to cause service of a certified copy of this order to be made upon Kiyoshi Nobusada, Kenneth H. Sato and Renzi Manaka or mail a certified copy to them at their last known address as shown on the Commission's récords.
