Decision No. 78052

BEFORE THE PUBLIC UTILITIES COMMISSION OF THE STATE OF CALIFORNIA

In the matter of the application of KARLSON BROS. TRUCKING SERVICE, a corporation, for authority under Section 3666 of the Public Utilities Code to continue to assess and collect transportation charges based on units of measurement and rates different from and in some instances lower than the minimum rates heretofore established by the Public Utilities Commission.

<u>OPINION</u>

Applicant requests authority, as a highway contract carrier, to transport tomato plants and empty carriers returning for I.K.I. Farms between Mecca and points in central California, at flat rates per crate. The transportation will be performed during the 1971 tomato plant season, which extends over approximately an eight-week period between February 15 and June 30.

Applicant previously has been authorized to deviate from the rates in Minimum Rate Tariff No. 2 for transportation of tomato plants for I.K.I. Farms. The latest such authority covered the 1970 tomato plant season (Decision No. 76716, dated January 27, 1970). By this application, authority is sought for the 1971 season to assess and collect rates on the same units of measurement, but increasing the rate from 80 to 85 cents per crate, and increasing the minimum charge from \$150 to \$160 per shipment. Applicant also proposes to eliminate Alameda County as a destination area.

Public hearing on the application was held at San Francisco on October 20, 1970, before Examiner Turpen. Applicant's accountant testified in support of the application. Representatives of the California Trucking Association and of the Commission's staff assisted in developing the record by cross-examining the witness.

The application states that, for accounting and sales reasons, I.K.I. Farms desires to continue to pay transportation charges on a system of flat rates per crate rather than upon a system of varying rates per 100 pounds. The application further states that the proposed rates and charges for the entire season's movement are expected to result in an operating profit to applicant, and will produce substantially more revenues to applicant than otherwise would accrue during this slack season.

The witness produced revenue and expense data for operations conducted during the 1970 season and projected revenue and expense data for the 1971 season. Without the tomato plant transportation applicant's equipment would not be fully utilized during an otherwise slack period.

The Commission finds that the proposed rates are reasonable. The Commission concludes the application should be granted.

<u>ORDER</u>

IT IS ORDERED that:

1. Karlson Bros. Trucking Service, a corporation, is authorized to transport tomato plants, in crates, with a declared valuation of \$5.00 per 100 pounds, and empty crates returning, for I.K.I. Farms, at rates different from the minimum rates but not less than those set forth in Appendix A attached hereto and by this reference made a part hereof.

SCHEDULE OF MINIMUM RATES FOR TRANSPORTATION OF TOMATO PLANTS FOR I.K.I. FARMS

Item 10. Application of Rates - Commodity.

Rates shall apply to the transportation of tomato plants, in lettuce crates, with a declared valuation of \$5.00 per 100 pounds; and to empty lettuce crates returning, or for return loaded movement of tomato plants.

Item 20. Application of Rates - Territory.

Rates shall apply to the transportation of tomato plants as described in Item 10 from Mecca to points in Central California (see Note 1) and to the transportation of empty crates as described in Item 10 from points in Central California (see Note 1) to Mecca.

- Note 1. Points in Central California include all points in the Counties of San Luis Obispo, Monterey, Santa Cruz, San Benito, Santa Clara, San Mateo, Contra Costa, San Joaquin, Yolo, Sacramento, Sutter, Yuba, Butte, Stanislaus, and Merced; and points in the Santa Maria Valley in Santa Barbara County.
- Item 30. Application of Rates General.

Rates include the service of transportation, including split delivery service.

Item 40. Rates on Tomato Plants as Described in Item 10.

From: Mecca To: Points in Central California (see Item 20) (1)

Rates in Cents per Crate

Tomato Plants Per Lettuce crate

(1) Subject to minimum quantity of 20,000 pounds calculated at 70 pounds per crate. Exception: On not to exceed ten shipments per season shipments may be less than 20,000 pounds but shall be subject to a minimum charge per shipment of \$160.
