SUPPLEMENTAL ORDER

By Decision No. 78048, entered December 8, 1970, in these proceedings, A & B Garment Delivery, A & B Garment Delivery of San Francisco, and Garment Carriers, Inc., were authorized to establish certain increased rates and charges to become effective not earlier than January 7, 1971. By Decision No. 78030, entered the same day

in Case No. 5432, Petition No. 596, said carriers were directed to increase certain other rates to become effective not later than January 1, 1971. The rates involved in said decisions are published in the same tariffs and are subject to surcharges. Compliance with the orders in the decisions would require the carriers to publish complete tariff publications which would be effective only six days; therefore,

IT IS ORDERED that Decision No. 78048 be and it is hereby amended by substituting the following language as the first ordering paragraph in said decision:

"1. A & B Garment Delivery, a corporation, A & B Garment Delivery of San Francisco, a corporation, and Garment Carriers, Inc., and each of them, are authorized to establish the increased rates proposed herein. Tariff publications authorized to be made as a result of the order herein shall be made effective not earlier than January 1, 1971, on not less than two days' notice to the Commission and to the public."

The effective date of this supplemental order shall be the date hereof.
