#### ORDER GRANTING PERMANENT CERTIFICATE OF PUBLIC CONVENIENCE AND NECESSITY

Applicant, Golden Pacific Airlines, Inc. (GFA), a California corporation, requests a certificate of public convenience and necessity, pursuant to Sections 2742 through 2765 of the Public Utilities Code, to transport passengers by air in either direction between Sacramento and Monterey, direct or with an intermediate stop at Oakland.

In view of the lack of any formal protest, a temporary certificate of public convenience and necessity was issued by this Commission in Decision No. 77731, dated September 15, 1970, on the advice of the Commission staff that consolidation of this application with GPA's petition to modify Decision No. 76668 in Application No. 51212 might be desirable.

A duly noticed prehearing conference was held on September 16, 1970. It was determined that consolidation was not necessary. The County of Sacramento appeared at the prehearing conference to express concern over possible discontinuance of service by GPA to Sacramento from various other points. A stipulation was agreed to by the two parties, and no protest was filed in this proceeding. As a result no further hearings are necessary, and the temporary authority will be made permanent.

After consideration the Commission finds that: 1. GPA possesses the necessary equipment, experience, insurance coverage, and financial ability to provide passenger air carrier service between Monterey and Sacramento via Oakland.

2. Public convenience and necessity require the granting of this authority.

3. A public hearing is not necessary.

Based upon the foregoing findings of fact, the Commission concludes that a certificate of public convenience and necessity should be granted to GPA authorizing it to operate nonstop between Monterey and Sacramento or with an intermediate stop at Oakland.

Golden Pacific Airlines, Inc., is hereby placed on notice that operative rights, as such, do not constitute a class of property which may be capitalized or used as an element of value in rate fixing for any amount of money in excess of that originally paid to the State as the consideration for the grant of such rights. Aside from their purely permissive aspect, such rights extend to the holder a full or partial monopoly of a class of business over a particular route. This monopoly feature may be modified or canceled at any time by the State, which is not in any respect limited as to the number of rights which may be given.

### <u>O R D E R</u>

IT IS ORDERED that:

1. A certificate of public convenience and necessity is granted to Golden Pacific Airlines, Inc., authorizing it to operate as a passenger air carrier as defined in Section 2741 of the Public Utilities Code, between the points and over the routes more

particularly set forth in Fourth Revised Page 2 and First Revised Page 3 of Appendix A, attached hereto and hereby made a part herof.

2. In providing service pursuant to the certificate herein granted, applicant shall comply with and observe the following service regulations. Failure to do so may result in a cancellation of the operating authority granted by this decision.

- (a) Within thirty days after the effective date hereof, applicant shall file a written acceptance of the certificate herein granted. By accepting the certificate of public convenience and necessity herein granted, applicant is placed on notice that it will be required, among other things, to file annual reports of its operations and to comply with and observe the insurance requirements of the Commission's General Order No. 120-A.
- (b) Within one hundred and twenty days after the effective date hereof, applicant shall establish the service herein authorized and file tariffs and timetables, in triplicate, in the Commission's office.
- (c) The tariff and timetable filings shall be made effective not earlier than five days after the effective date of this order on not less than five days' notice to the Commission and the public, and the effective date of the tariff and timetable filings shall be concurrent with the establishment of the service herein authorized.
- (d) The tariff filings made pursuant to this order shall comply with the regulations governing the construction

and filing of tariffs set forth in the Commission's General Order No. 105-A.

- 4. Passengers shall be carried whose transportation is solely between the respective airports of SFO and SJC, per temporary authority (D.77611).
- 5. Passengers shall be carried whose transportation is solely between the respective airports of SFO and PAO, PAO and SJC, per temporary authority.
- #6. Condition deleted.
  - 7. No aircraft having more than 25 revenue passenger seats shall be operated.
