STIPULATION

It is hereby stipulated by the undersigned that:

1. Of the violations of underestimate reporting to the Commission alleged to have been committed, 173 are admitted by the respondent.
2. The fine proposed to be payable to the Commission by respondent Bekins Moving and Storage Co. is \$4,000, payable in full for all claims arising out of the above proceeding.
3. Respondent Bekins Moving and Storage Co. shall cease and desist from further failure to report underestimates as required by the Commission.
4. In the event the Public Utilities Commission of the State of California declines to approve this Stipulation, the same shall be void.

### OPINION

Hearing on this matter was ordered March 31, 1970. Since the date of such order, Counsel for Respondent and Counsel for the Commission staff have entered into a stipulation respecting the number of violations of underestimate reporting to the Commission herein under investigation and the proper penalty therefor. Based upon said stipulation, the Commission finds that there were 173 violations and the Commission concludes that a fine of \$4,000 is proper for the violations here in question.

O R D E R

IT IS ORDERED that:

1. Said Bekins Moving and Storage Co. shall pay a fine of \$4,000 to this Commission on or before the fifteenth day after service hereof.
2. Said Bekins Moving and Storage Co. shall cease and desist from further failure to report underestimates as required by this Commission.

The Secretary of the Commission is directed to cause personal service of this order to be made upon respondent Bekins Moving and Storage Co.
