It is hereby stipulated by the undersigned that:

1. The violations of underestimate reporting to the Commission alleged to have been committed are admitted by the respondent.

2. The fine proposed to be payable to the Commission by respondent Nacal, Inc. is \$1,000, payable in full for all violations.

3. Respondent Nacal, Inc. shall cease and desist from further failure to report underestimates as required by the Commission.

4. In the event the Public Utilities Commission of the State of California declines to approve this Stipulation, the same shall be void.
