ORDER TO SHOW CAUSE

It appearing that Valen Parking Management, Inc., a California corporation, hereinafter referred to as Valen, is engaged in the business of transporting persons over the public highways of this State and is presently operating buses between the City of Anaheim and the City of Buena Park on what appears to be scheduled passenger service and is charging fares on an individual basis, and it appearing that Valen does not possess a certificate of public convenience and necessity as required by Section 1031 of the California Public Utilities Code; and

It further appearing that pursuant to Decision No. 77723, dated September 15, 1970 in Case No. 9063, Valen was ordered to cease and desist from operating passenger stages to Knotts Berry Farm over the present route that is described in those proceedings to the extent that they proceed beyond the city limits of the City of Anaheim and that it shall not operate more than 2 per cent of its total route mileage outside the City of Anaheim; and

It further appearing that almost 10 per cent of the routes that Valen is operating are outside the City of Anaheim; and good cause appearing,

IT IS ORDERED that Valen appear before Examiner Rogers at 10:00 a.m. on January 28 and 29, 1971, in the Courtroom of the Public Utilities Commission, State Building, 107 South Broadway, Los Angeles, California, for the following purposes:

- (1) To determine whether Valen has violated any order or decision of the Commission in Decision No. 77723 or any provision of the Public Utilities Code;
- (2) For Valen to show cause, if any should exist, why it should not be ordered to cease and desist its operations as set forth in Decision No. 77723;
- (3) For Valen to show cause, if any should exist, why Valen should not be adjudged to be in contempt of the Public Utilities Commission of the State of California and punished therefor in the manner prescribed by law;
- (4) To determine whether any other order or orders that may be appropriate should be entered in the lawful exercise of the Commission's jurisdiction.

IT IS FURTHER ORDERED that a true copy of this order be personally served upon an officer of Valen at least ten (10) days prior to the time hereinabove fixed for the hearing of this order to show cause.
