ORDER DENYING RECONSIDERATION, MODIFICATION, OR REHEARING

Petition has been filed by California Trucking Association (CTA) for reconsideration, modification or rehearing of Decision No. 78264. Said decision found it reasonable to revise certain minimum rates, rules, and regulations within those portions of Los Angeles and Orange counties embraced by the 58-zone area adopted by the Commission for that purpose in Decision No. 61419. Said petition, being timely filed by CTA, suspended the order of Decision No. 78264. Following this, the Commission, on March 2, 1971, in Decision Nos. 78390, 78391, 78392, 78393, 78394, 78395, 78396 and 78397 ordered suspension of the tariff pages authorized by Decision Nos. 78265, 78266, 78267, 78268, 78269, 78270, and 78271. The latter decisions were companion orders to Decision No. 78264.

One significant effect of Decision No. 78264 is the reduction of certain minimum rates in the 58-zone area. These reductions apply to those shipments between 400 and 3500 pounds that were previously rated on the MRT-2 general statewide rates. From the extensive cost data in the record, it is apparent that the statewide MRT-2 rates are unreasonably high as applied to these shipments. This decision reaffirms the reasonableness of the rates as established in Decision No. 78264. It is to be noted that any rate reductions occasioned by Decision No. 78264 are permissive in nature. The old and higher rate can still be legally charged. Furthermore, there was no evidence in the record that competitive considerations would require carriers to charge the new and lower minimum rate. The Commission has considered each and every allegation raised by petitioner and is of the opinion that no good cause for reconsideration, modification, or rehearing has been made to appear. THEREFORE, IT IS ORDERED that petitioner's request for reconsideration, modification, or rehearing of Decision No. 78264 is hereby denied. IT IS FURTHER ORDERED that: 1. The ordering paragraphs in Decision Nos. 78264, 78265, 78266, 78267, 78268, 78269, 78270, 78271, 78326, and 78327, which refer to March 13, 1971, are hereby amended by substituting April 24, 1971 for March 13, 1971, as shown therein. 2. Minimum Rate Tariffs 2, 3-A, 5, 7, 11-A, 15 and 17 and Exception Ratings Tariff 1 (Appendices D, A, A, A, A, B, A and A of Decision Nos. 31606, 55587, 32504, 32566, 50114, 65072, 69469 and 66195 as amended, respectively) are hereby further amended by incorporating therein Vacating Supplement to said tariffs, which - 2 -

Vacating Supplement is attached hereto and by this reference made a part hereof.

3. In all other respects Decision Nos. 31606, 32504, 32566, 50114, 55587, 65072, 66195, and 69469 as amended shall remain in full force and effect.

This order shall become effective the date hereof.
