In the Matter of the Suspension and Investigation on the Commission's own motion of the tariff sheets covering the offering of "Automated Interconnected Mobile Telephone Service" filed under Advice Letter No. 22 by Industrial Communications Systems, Inc.

Case No. 9128 (Filed September 29, 1970)

ORDER OF DISCONTINUANCE

Industrial Communications Systems, Inc., on September 2, 1970, under Advice Letter No. 22, filed certain tariff sheets providing for "automated interconnected mobile telephone service".

On September 18, 1970 Pomona Radio Dispatch Corporation filed a complaint, Case No. 9123, protesting the "automated interconnected mobile telephone service" tariff sheets filed by defendant under cover of its Advice Letter No. 22. Thereafter, the Commission issued an order of suspension and investigation of said tariff sheets which was docketed as Case No. 9128.

A prehearing conference in Case No. 9128 was held before Examiner Gillanders in Los Angeles on October 20, 1970.

On October 26, 1970 Allied Telephone Companies Association (Allied) filed a petition to intervene in the above two matters.

Following a discussion of the issues at the prehearing conference, complainant met with representatives of defendant and considered the matter further.

By letter dated November 13, 1970, Pomone withdrew its objections to the "automated interconnected mobile telephone service" tariff sheets filed by defendant and requested that Case No. 9123 be dismissed.

C. 9128 hjh

By letter dated November 17, 1970, Allied stated that it "is of the opinion that the disposition of this matter by dismissal, as proposed by Pomona, is in the public interest. Accordingly, Allied respectfully requests either permission to withdraw its petition to intervene or, in the alternative, that said petition be denied."

On January 25, 1971 Industrial refiled the tariff sheets under cover of Advice Letter No. 23.

Advice Letter No. 23 was approved by Commission Resolution T-7271 on February 9, 1971 and the tariff sheets became effective on February 10, 1971.

By Decision No. 78353 in Case No. 9123, dated February 22, 1971, Allied's petition to intervene was denied and Case No. 9123 was dismissed with prejudice.
