SUPPLEMENTAL OPINION AND ORDER

By Decision No. 60965 dated October 25, 1960 in Application No. 42276 as amended by Decision No. 61813 dated April 11, 1961, Special Service Transportation Corporation, Ltd., was granted a certificate of public convenience and necessity which authorized the transportation of motion picture films and related commodities and also, commodities dealt in by retail and wholesale grocery establishments between the Los Angeles Territory on the one hand and Mettler, Fresno and other points on the other hand.

On July 10, 1970, Golden West Freight Lines, a corporation, filed Application No. 52030 (later amended) which sought authority to extend highway common carrier service. Application No. 52030 alleged corporate affiliation between Special Service Transportation Corporation, Ltd. and Golden West Freight Lines. In Application No. 52030, Special Service Transportation Corporation, Ltd. submitted a written consent that its certificate may be restricted to avoid duplication with the authority sought by Golden West Freight Lines. Accordingly, its certificate should be amended to avoid duplication of authority granted to Golden West Freight Lines by Decision No. 78633 dated MAY - 4 1971 in Application No. 52030. A public hearing is not necessary.






IT IS ORDERED that:

2. Within sixty days after the effective date hereof and on not less than 10 days' notice to the Commission and to the public, applicant shall amend its tariffs presently on file with the Commission to reflect the authority herein granted.

(a corporation)

Special Services Transportation Corporation, Ltd., a corporation, by the certificate of public convenience and necessity granted by Decision 60965, is authorized to transport the following commodities between the points and places hereinafter enumerated:

I. Motion picture films, film supplies and accessories limited to projecting machinery and parts thereof, lighting effect including carbons and bulbs, advertising matter, tickets, programs, candy, chewing gum, popcorn bags and boxes, between Los Angeles, Greenfield, Ford City, Taft, Buttonwillow, Oildale, Bakersfield, Arvin, Lamont, Tehachapi, Mojave, Ridgecrest, Trona, Camp Irwin, Barstow, Lenwood, Victorville, Boron, Murdoc, Deuel Vocational Institute, Lancaster and Palmdale, subject to the following conditions:

- a. Applicant shall transport only shipments originating at or consigned to theatres, churches and schools, and other places where films are shown.
- b. Applicant shall conduct operations over and along U. S. Highways 6, 66, 99, 395, 399 and 466; State Highway 178 and any and all other streets, roads and highways necessary or convenient for the performance of the service herein authorized.
