OPINION AND ORDER

Southern California Edison Company (Edison) and Anza Electric Cooperative, Inc. (Anza) jointly request an order amending the boundary lines separating their respective service areas.

Edison was authorized by this Commission to exercise the rights and privileges granted by Franchise Ordinance No. 259 in the County of Riverside pursuant to Application No. 23634, in Decision No. 34723, dated November 4, 1941.

Anza has been authorized by this Commission to construct and operate a public utility electric transmission and distribution system in that portion of Riverside County delineated as the requested service area of Anza in Application No. 33637, and has been authorized to exercise the rights, privileges and franchise granted by Ordinance No. 395 of the County of Riverside within said service area, pursuant to Application No. 33637, Decision No. 47988, dated December 2, 1952, as amended by Application No. 50515, Decision No. 74878, dated October 29, 1968.

The application states, in order that electric service may be provided to various prospective customers adjacent to Edison's service lines at a minimum cost, Anza is willing to release a portion of Section 34, Township 5 South, Range 3 East of San Bernardino Base and Meridian included within its service area to Edison, which has indicated willingness to provide said service. A description of the proposed revised boundary line within Section 34, T5S, R3E, SBBM, is attached to the application marked Exhibit "A". A map showing the detail of the proposed service area of Anza to be released to Edison is attached to the application marked Exhibit "B".

The Commission finds that public convenience and necessity require that the certificate granted to Anza to operate a public utility in a portion of Riverside County be amended as requested herein and that Edison provide electric service within said portion of Riverside County released by Anza. A public hearing is not necessary.


IT IS ORDERED that:

1. The certificate of public convenience and necessity issued to Anza Electric Cooperative, Inc. by Decision No. 47988 and as amended by Decision No. 74878, delineating its service area in Riverside County, be amended to exclude that portion of Section 34, Township 5 South, Range 3 East of San Bernardino Base and Meridian as described in Exhibits "A" and "B" of Application No. 52452.
2. Decision No. 47988 as amended by Decision No. 74878 in all other respects shall remain in full force and effect.


3. Applicants shall each, within thirty days after the effective date of this order, file four copies of its tariff service area map, in accordance with General Order No. 96-A which will reflect the boundaries authorized by this order.

The effective date of this order shall be the date hereof.




