ORDER AMENDING WAREHOUSE OPERATIVE RIGHT

Los Angeles Cold Storage Company, a corporation, possesses a certificate of public convenience and necessity as a public utility warehouseman for the operation of freezer and cooler storage warehouse floor space at Pasadena, Pomona and Los Angeles.

The warehouse facility of Los Angeles Cold Storage Company at Pomona was completely destroyed by fire in July of 1969. By Resolution No. TS-063, dated September 23, 1969, in this proceeding, the certificate of public convenience and necessity for the Pomona location was suspended until January 1, 1971, to allow the warehouseman time to determine whether it should rebuild, relocate or discontinue its facility at Pomona.

Los Angeles Cold Storage Company has informed the Commission by letter that it has come to the conclusion, after careful study and consideration, that there is not enough business in the area to warrant rebuilding the facility and it requests that the operative right for its Pomona location be revoked.

In the circumstances, it appears, and the Commission finds, that amendment of the certificate to exclude operations at Pomona would not be adverse to the public interest. A public hearing is not necessary. The Commission concludes that the certificate should be amended accordingly and that the tariff applicable to the services thereunder should be canceled.

IT IS ORDERED that:

- 1. The certificate of public convenience and necessity granted to los Angeles Cold Storage Company, a corporation, by Decision No. 74819 dated October 15, 1968, in Application No. 50503 is hereby amended by incorporating in Appendix A thereof First Revised Page 1, attached hereto, in revision of Original Page 1.
- 2. Jack L. Dawson, Agent, is hereby authorized and directed to cancel the participation of Los Angeles Cold Storage Company (Pomona operations only) from his Warehouse Tariff No. 2-H, Cal.P.U.C. No. 210, on file with the Commission, such cancellation to be made within ninety days after the effective date of this order on not less than ten days' notice to the Commission and to the public.

The Secretary is directed to cause service of a certified copy of this order to be made upon Los Angeles Cold Storage Company or to mail a certified copy thereof to it at its last known address as shown in the Commission's records and to mail a copy of this order to Jack L. Dawson, Agent.
