In the Matter of the Application of CITY TRANSFER, INC., a corporation, to sell, and of G. & S. INDUSTRIES, INC., a corporation, to purchase, a cement carrier certificate authorizing service to and within the Counties of Kern, Los Angeles, Orange, Riverside and San Bernardino, in the State of California, pursuant to Sections 851-853 of the California Public Utilities Code.

Application No. 52586 (Filed April 28, 1971)

<u>OPINION</u>

City Transfer, Inc., requests authority to sell and transfer, and G. & S. Industries, Inc., requests authority to purchase and acquire, a certificate of public convenience and necessity authorizing operations as a cement carrier.

The certificate was granted by Decision No. 73667, dated January 30, 1968, in Application No. 49857 and authorizes the transportation of shipments of cement to and within the Counties of Kern, Los Angeles, Orange, Riverside and San Bernardino. The agreed cash consideration is \$6,600. Applicant purchaser is a recently formed corporation, which has arranged to purchase new units of motor vehicle equipment specifically designed for the transportation of cement in bulk, in pneumatic trailers. As of March 31, 1971, it indicated a net worth in the amount of \$15,000.

After consideration the Commission finds that the proposed transfer would not be adverse to the public interest. A public hearing is not necessary. The order which follows will provide for,

own, said rates and rules. The tariff filings shall be made effective not earlier than five days after the effective date of this order on not less than five days' notice to the Commission and the public, and the effective date of the tariff filings shall be concurrent with the consummation of the transfer herein authorized. The tariff filings made pursuant to this order shall comply in all respects with the regulations governing the construction and filing of tariffs set forth in the Commission's General Order No. 117. Failure to comply with and observe the provisions of General Order No. 117 may result in a cancellation of the operating authority granted by this decision.

- 4. On or before the end of the third month after the consummation of the transfer as herein authorized, purchaser shall cause to be filed with the Commission, in such form as the Commission may prescribe, an annual report, or reports, related to the operations of the seller for the period commencing with the first day of the current year to and including the effective date of the transfer.
- 5. In the event the transfer authorized in paragraph 1 hereof is consummated, a certificate of public convenience and necessity is granted to G. & S. Industries, Inc., authorizing it to operate as a cement carrier, as defined in Section 214.1 of the Public Utilities Code, between the points set forth in Appendix A, attached hereto and made a part hereof.
- 6. The certificate of public convenience and necessity granted in paragraph 5 of this order shall supersede the certificate of public convenience and necessity granted by Decision No. 73667, which certificate is revoked effective concurrently with the effective date of the tariff fillings required by paragraph 3 hereof.

- 7. Within thirty days after the transfer herein authorized 1s consummated, purchaser shall file a written acceptance of the certificate herein granted. Purchaser is placed on notice that, if it accepts the certificate of public convenience and necessity herein granted, it will be required, among other things, to comply with and observe the safety rules of the California Highway Patrol, and insurance requirements of the Commission's General Order No. 100-F.
- 8. Purchaser shall maintain its accounting records on a calendar year basis in conformance with the applicable Uniform System of Accounts or Chart of Accounts as prescribed or adopted by this Commission and shall file with the Commission, on or before March 31 of each year, an annual report of its operations in such form, content, and number of copies as the Commission, from time to time, shall prescribe.
- 9. Purchaser shall comply with the requirements of the Commission's General Order No. 84-Series for the transportation of collect on delivery shipments. If purchaser elects not to transport collect on delivery shipments, it shall make the appropriate tariff filings as required by the General Order.

The effective date of this order shall be twenty days after the date hereof.

G. & S. Industries, Inc., a corporation, by the certificate of public convenience and necessity granted by the decision noted in the margin, is authorized to conduct operations as a cement carrier as defined in Section 214.1 of the Public Utilities Code from any and all points of origin to any and all points within the Counties of Kern, Los Angeles, Orange, Riverside and San Bernardino subject to the following restriction:

This certificate of public convenience and necessity shall lapse and terminate if not exercised for a period of one year.
