## ORDER REVOKING OPERATING AUTHORITY

By Decision No. 75638 dated June 24, 1969, in Application No. 50656, Clyde Robbins, Cletus L. Abbott and Allen Robbins were granted a Certificate of Public Convenience and Necessity to operate as a passenger stage corporation between United Airlines Service Center, at or near San Francisco International Airport and the Cities of San Jose, Sunnyvale and Santa Clara, respectively.

Clyde Robbins, Cletus L. Abbott and Allen Robbins have expressed their desire in writing to have their operating authority revoked due to insufficient patronage. The carrier discontinued service on October 10, 1970. Appropriate notice was given to all passengers on or about September 15, 1970. No protests to discontinuance of the service have been received.

It appears and the Commission finds that these matters constitute good cause for the revocation of the aforenamed certificate. The Commission, therefore, concludes that the certificate should be revoked and that tariffs and timetables applicable to the service thereunder should be canceled.

IT IS ORDERED that the Certificate of Public Convenience and Necessity to operate as a passenger stage corporation as defined in Section 226 of the Public Utilities Code between United Airlines Service Center at or near San Francisco International Airport and the Cities of San Jose, Sunnyvale and Santa Clara, respectively authorized by Decision No. 75638 in Application No. 50656 is hereby revoked, and all effective tariffs and timetables on file with the Commission in the names of Clyde Robbins, Cletus L. Abbott and Allen Robbins are canceled upon the effective date of this order.
