ORDER OF REVOCATION

*ES* By Decision No. 69887, dated November 2, 1965, in Application No. 478~~8~~<sup>4</sup> and by Decision No. 75584, dated April 22, 1969, in Application No. 50945, Eastern Cities Transit, Inc. was granted a Certificate of Public Convenience and Necessity to operate a passenger stage corporation for the transportation of passengers between points in the East Los Angeles Area of the County of Los Angeles.

On July 27, 1971, Charles Boehm, Treasurer for Eastern Cities Transit, Inc. and George F. Goehler, Manager of Operations for the Southern California Rapid Transit District, a public corporation, notified this Commission by joint letter of negotiations being currently conducted by both parties to sign an agreement whereby Eastern Cities Transit, Inc. will sell to the District certain of its buses, equipment, real property and will relinquish its local transit operating rights in favor of the District. The terms of the contract, however, provide that Eastern Cities Transit, Inc. will retain its Charter-party Carrier of Passengers Class A Certificate issued by this Commission.

In order to provide an orderly and efficient transition and to assure uninterrupted service both parties have requested that the Certificate of Public Convenience and Necessity to operate as a passenger stage corporation currently held by Eastern Cities Transit, Inc. be revoked on September 1, 1971 subject to the execution of an agreement between Eastern Cities Transit, Inc. and the Southern California Rapid Transit District.

It appears and the Commission finds that these matters constitute good cause for the revocation of the aforementioned certificate. The Commission, therefore, concludes that the certificate should be revoked and that tariffs and timetables applicable to the service thereunder should be canceled.





O R D E R

*EIS* IT IS ORDERED that the Certificate of Public Convenience and Necessity to operate as a passenger stage corporation for the transportation of passengers in the East Los Angeles Area of the County of Los Angeles authorized by Decision No. 69887 in Application No. 478~~8~~<sup>4</sup> and Decision No. 75584 in Application No. 50945 is hereby revoked and all effective tariffs and timetables on file with the Commission in the name of Eastern Cities Transit, Inc. are canceled effective September 1, 1971. This authority is conditioned on (1) the Southern California Rapid Transit District entering into a contract with Eastern Cities Transit, Inc. to purchase certain equipment and property of the latter and (2) the District commencing operation, on September 1, 1971, of passenger stage service on routes now served by Eastern Cities Transit, Inc.

The Secretary is directed to mail a certified copy of this order to Charles Boehm, Treasurer, Eastern Cities Transit, Inc., 2500 East 12th Street, Los Angeles, California 90021, and to George F. Goehler, Manager of Operations, Southern California Rapid Transit District, 1060 South Broadway, Los Angeles, California 90015.

The effective date of this order shall be September 1, 1971. Before such effective date, the Southern California Rapid Transit District or Eastern Cities Transit, Inc. shall file with the Commission a duly executed copy of the above-mentioned contract between said parties. In the event that such contract is not filed with the Commission prior to September 1, 1971, or that service is not commenced on that date by Southern California Rapid Transit District or Eastern Cities Transit, Inc. routes, this order shall be stayed until further order of the Commission.
