INTERIM TARIFF SUPPLEMENT AND ORDER EXTENDING EXPIRATION DATES

In view of the Executive Order of the President of the United States, announced August 15, 1971, imposing a freeze on price and wage increases for ninety days, the expiration of certain tariff items will be extended until further order of the Commission.

4. Tariff publications of common carriers shall be made effective not later than September 30, 1971, on one day's notice to the Commission and the public.

IT IS ORDERED that:

5. Common carriers, in establishing and maintaining the provisions authorized hereinabove, are hereby authorized to depart from the provisions of Section 460 of the Public Utilities Code to the extent necessary to adjust long- and short-haul departures now maintained under outstanding authorizations; such outstanding authorizations are hereby modified only to the extent necessary to comply with this order; and schedules containing the provisions published under this authority shall make reference to the prior orders authorizing long- and short-haul departures and to this order.

1. Minimum Rate Tariff No. 2 (Appendix D to Decision No. 31606, as amended) is further amended to provide that the expiration date of the following tariff items is extended until further order of the Commission.

- Item 42 - Note 16
Item 330 - Carriers (Used Packages) Secondhand, Empty
Item 330.5- Carriers (Used Packages) Secondhand, Empty

6. In all other respects said Decisions Nos. 31606, 65834 and 66195, as amended, shall remain in full force and effect.

2. Minimum Rate Tariff No. 1-B (Appendix B) of Decision No. 65834, as amended) is further amended to provide that the expiration date of the following tariff item is extended until further order of the Commission.

- Item 430 - Carriers (Used Packages), Secondhand, Empty

The effective date of this order shall be the date hereof.

3. Exception Ratings Tariff No. 1 (Appendix A to Decision No. 66195, as amended) is further amended to provide that the expiration date of the following tariff items is extended until further order of the Commission.

- Item 80 - Carriers (Used Packages)
Item 280 - Carriers, Old, Used
Item 300 - Carriers (Used Packages)
Item 340 - Carriers (Used Packages)
Item 820 - Returned Shipments
