SUPPLEMENTAL OPINION AND ORDER

Dean Van & Storage, Inc., a corporation, possesses a prescriptive operative right as a public utility warehouseman for the operation of storage or warehouse space at Dominguez.

W. L. Eggleston, Comptroller for Dean Van Lines, Inc. has filed with this Commission a Merger Agreement and an amended Articles of Incorporation indicating that Dean Van & Storage, Inc., and Dean International Ltd. were merged into Dean Van Lines, Inc., and that Dean Van Lines, Inc. became the surviving corporation. Accordingly, the operative right will be amended to show the new corporate name and the warehouseman will be ordered to amend its tariff pursuant to General Order No. 61-A. A public hearing is not necessary.

IT IS ORDERED that:

- l. The prescriptive operative right as a public utility warehouseman possessed by Dean Van & Storage, Inc. as determined by order of the Commission dated July 26, 1960, in Case No. 6653 is amended by substituting "Dean Van Lines, Inc." in place and stead of "Dean Van & Storage, Inc."
- 2. Order of the Commission dated July 26, 1960, in Case No. 6653 is amended by substituting for Appendix "A" thereof Original Page 1 of Appendix A attached hereto and by this reference made a part hereof.

3. Within one hundred twenty days after the effective date hereof and on not less than ten days' notice to the Commission and to the public, Dean Van Lines, Inc. shall amend its tariff on file with this Commission as required by Rule 6.2 of General Order No. 61-A.

The Secretary is directed to cause service of a certified copy of this order to be made upon Dean Van Lines, Inc., or to mail a certified copy thereof to it at its last known address as shown in the Commission's records.

This order shall become effective twenty days after the date hereof.
