SUPPLEMENTAL OPINION AND ORDER

By Decision No. 62960, dated December 19, 1961, as amended, San Jose City Lines, Inc., was ordered to acquire new buses as follows:

<u>No. of Buses</u>	<u>Shall be Acquired Prior to:</u>
5	January 1, 1972
5	January 1, 1973
5	January 1, 1974
4	January 1, 1975

By its petition filed November 11, 1971, applicant requests that the time for acquisition of new buses be extended as follows:

<u>No. of Buses</u>	<u>Shall be Acquired Prior to:</u>
5	January 1, 1973
5	January 1, 1974
5	January 1, 1975
4	January 1, 1976

Pursuant to the directive petitioner has acquired new buses since 1962, the most recent of which were acquired in August and October of 1967. As of September 30, 1971, petitioner is indebted under contract for the purchase of said buses in the amount of \$61,125, representing the unpaid principal balance of the purchase price.

It is alleged that petitioner does not presently have cash available to purchase additional buses; that its operating losses for the first nine months of 1971 amounted to \$3,737; that in June 1971 petitioner entered into an agreement with the City of San Jose

whereby the City agreed to provide financial assistance in the amount of \$25,000 a month; that the agreement makes no provision for the purchase of new equipment; and that petitioner's existing fleet of buses is in very good physical condition.

Therefore, good cause appearing,





IT IS ORDERED that the requirements of Ordering Paragraph 6 of Decision No. 62960, as amended by Decisions Nos. 73836, 75282, 76986 and 77953, are modified as follows:

6. San Jose City Lines, Inc., shall acquire 19 new motor buses in replacement of older buses prior to January 1, 1976, and the number of buses acquired and the dates of acquisition shall not be less in number nor subsequent in time of acquisition than specified in the following schedule:

<u>No. of Buses</u>	<u>Shall be Acquired Prior to:</u>
5	January 1, 1973
5	January 1, 1974
5	January 1, 1975
4	January 1, 1976

The effective date of this order shall be the date hereof.
