O P I N I O N

This is an application by Pacific Lighting Service Company seeking authority to exercise a franchise from the City of Culver City.

Applicant is engaged in transmission of natural gas to Southern California Gas Company for distribution in the central and southern portions of the State of California. The verified application avers that on January 13, 1969, the City Council of the City of Culver City enacted Ordinance No. CS-614, which grants applicant a franchise to lay and use pipes and appurtenances for transmitting and distributing gas for a period of 27 years. The application indicates that it is necessary to exercise the franchise in order to transport gas from a Standard Oil facility in Baldwin Hills to a Southern California Gas Company line in Culver City. Applicant has included in the application a stipulation that it will not claim before the Commission or any court or any other public body any value for the franchise in excess of its original cost which is stated to be \$186.35.

Ordinance No. CS-614 is attached to the application as Exhibit A. Examination of the ordinance indicates that the franchise granted therein is of the standard type between gas utilities and

cities. It provides for a payment of 2 percent of applicant's annual gross receipts, arising out of the use, operation or possession of the particular franchise, provided however, that such payment shall in no event be less than 1 percent of the gross annual receipts of the applicant derived from the sale of gas within the city limits.

The Commission is of the opinion that the application should be granted. No other points require discussion.

The Commission makes the following findings and conclusions in this matter.

Findings of Fact

The Commission finds that:

1. A public hearing is not necessary in this matter.
2. Public convenience and necessity require the exercise by Pacific Lighting Service Company of the rights and privileges granted in the franchise conferred by Ordinance No. CS-614 of the City Council of the City of Culver City.

Conclusions of Law

The Commission concludes that:

1. The application should be granted.
2. The certificate of public convenience and necessity issued herein is subject to the following provisions of law:
  - a. The Commission shall have no power to authorize the capitalization of the franchise involved herein or this certificate of public convenience and necessity, or the right to own, operate or enjoy such franchise or certificate of public convenience and necessity in excess of the amount (exclusive of any tax or annual charge) actually paid to the State or to a political subdivision thereof as the consideration for the issuance of such franchise, certificate of public convenience and necessity or right.

- b. The franchise involved herein shall never be given any value before any court or other public authority in any proceeding of any character in excess of the cost to the grantee of the necessary publication and any other sum paid by it to the municipality therefor at the time of the acquisition thereof.

O R D E R

IT IS ORDERED that a certificate of public convenience and necessity is granted to Pacific Lighting Service Company to exercise the rights and privileges conferred by the franchise issued pursuant to Ordinance No. CS-614 of the City Council of the City of Culver City.

The effective date of this order shall be twenty days after the date hereof.
