## <u>O P I N I O N</u>

Northgate Transit Co., Inc., presently rendering a passenger stage service between points in northern San Mateo County and the City of San Francisco, requests authority to adjust and extend its present Routes Nos. 1 and 2 to provide service to Skyline College on a six-month trial basis. Applicant does not propose any increase in fares. The application states that requests for service have been received from various interested persons including Homeowners Associations and Skyline College. There are no protests.

After consideration, the Commission finds that:

1. Applicant possesses the experience, equipment and personnel to institute and maintain the proposed service.

2. Public convenience and necessity require that the application be granted as set forth in the ensuing order.

3. A public hearing is not necessary.

The Commission concludes that since there is no statutory provision for the granting of passenger stage corporation certificates of public convenience and necessity on a trial basis, the application should be granted on a permanent basis as set forth in the ensuing order. If after six months applicant believes that public convenience and necessity no longer require the service, applicant should apply to have its certificate amended or revoked. Applicant's operating authority will be restated.

#### A. 52909 JM

Applicant is hereby placed on notice that operative rights, as such, do not constitute a class of property which may be capitalized or used as an element of value in rate fixing for any amount of money in excess of that originally paid to the State as the consideration for the grant of such rights. Aside from their purely permissive aspect, such rights extend to the holder a full or partial monopoly of a class of business over a particualr route. This monopoly feature may be modified or canceled at any time by the State, which is not in any respect limited as to the number of rights which may be given.

In granting of authority herein the attached certificate will consolidate all previous authority.

#### ORDER

#### IT IS ORDERED that:

1. A certificate of public convenience and necessity is granted to Northgate Transit Co., Inc., a corporation, authorizing it to operate as a passenger stage corporation, as defined in Section 226 of the Public Utilities Code, between the points and over the routes particularly set forth in Appendix A, attached hereto and made a part hereof.

2. In providing service pursuant to the certificate herein granted, applicant shall comply with and observe the following service regulations. Failure so to do may result in a cancellation of the operating authority granted by this decision.

- (a) Within thirty days after the effective date hereof, applicant shall file a written acceptance of the certificate herein granted. Applicant is placed on notice that, if it accepts the certificate of public convenience and necessity herein granted, it will be required, among other things, to comply with and observe the safety rules of the California Highway Patrol, the rules and other regulations of the Commission's General Order No. 98-A and insurance requirements of the Commission's General Order No. 101-C.
- (b) Within one hundred twenty days after the effective date hereof, applicant shall establish the service herein authorized and file tariffs and timetables, in triplicate, in the Commission's office.

- (c) The tariff and timetable filings shall be made effective not earlier than five days after the effective date of this order on not less than five days' notice to the Commission and the public, and the effective date of the tariff and timetable filings shall be concurrent with the establishment of the service herein authorized.
- (d) The tariff and timetable filings made pursuant to this order shall comply with the regulations governing the construction and filing of tariffs and timetables set forth in the Commission's General Orders Nos. 79 and 98-A.
- (e) Applicant shall maintain its accounting records on a calendar year basis in conformance with the applicable Uniform System of Accounts or Chart of Accounts as prescribed or adopted by this Commission and shall file with the Commission, on or before March 31 of each year, an annual report of its operations in such form, content, and number of copies as the Commission, from time to time, shall prescribe.

3. Concurrent with the effective date of the tariff filings required by paragraph 2(b) hereof, the operating authority granted by Decision No. 63259 in Application No. 44016, as amended by Decision No. 74828 in Application No. 50513, is hereby revoked.

# SECTION 1. GENERAL AUTHORIZATIONS, RESTRICTIONS, LIMITATIONS AND SPECIFICATIONS.

Northgate Transit Co., Inc., by the certificate of public convenience and necessity granted by the decision noted in the margin, is authorized to transport passengers between points in the Cities of Daly City, South San Francisco, Colma, San Bruno, City and County of San Francisco and adjacent areas over the routes described in Section 2, and subject to the following conditions:

- 1. Motor vehicles may be turned at termini and intermediate points, in either direction, at intersections of streets or by operating around a block contiguous to such intersections in accordance with local traffic regulations.
- 2. No passenger shall be transported on Route No. 3 having both point of origin and point of destination within the City and County of San Francisco between the intersection of Mission Street and Templeton Avenue and the intersection of Alemany Boulevard and Junipero Serra Boulevard.
