ORDER SUSPENDING OPERATING RIGHTS

There are presently pending before the Commission Applications Nos. 52854, 52964 and 52986. In Application No. 52854, Loomis Courier Service, Inc. seeks to have its certificates of public

convenience and necessity to operate as a freight forwarder and express corporation cancelled. Application No. 52964 is one by United Clearings, Inc. seeking similar relief. American Courier Corporation is the applicant in Application No. 52986. American alleges that it is in direct competition with Loomis and United and that Loomis and United have not filed certain tariffs required by law. American seeks alternative relief: (1) that Loomis and United be required to file requisite tariffs or (2) that its operating authority be cancelled or suspended so that it can compete with Loomis and United on equal terms.

The Commission, in previous orders, granted Loomis and United an extension of time, to March 1, 1972, in which to file appropriate tariffs and granted American authority to suspend its operating rights as an express corporation to March 1, 1972.

A public hearing was held in Applications Nos. 52854, 52964 and 52986 before Examiner Jarvis on January 25, 26 and 27, 1972. The matters were submitted subject to the filing of transcripts and briefs, none of which have yet been filed.

American has filed a request seeking extension of the suspension of its express corporation operating rights until July 1, 1972, pending the disposition of the aforesaid applications. In the circumstances, the Commission is of the opinion and finds that American's certificate of public convenience and necessity to operate as an express corporation should be temporarily suspended until July 1, 1972.

IT IS ORDERED that the certificate of public convenience and necessity to operate as an express corporation granted to American Courier Corporation by Decision No. 76434 in Application

No. 51458 and Decision No. 76236 in Application No. 50963 is hereby suspended until July 1, 1972.
