ORDER MODIFYING DECISION AND DENYING PETITIONS FOR REHEARING, MODIFICATION AND INTERVENTION

A petition for rehearing and/or modification of Decision No. 78800 having been filed by The Pacific Telephone and Telegraph Company and a petition for leave to intervene and for rehearing and/or modification having been filed by Continental Telephone Company of California, the Commission having considered each and every allegation thereof, and being of the opinion that good cause for modification has been made to appear,

IT IS ORDERED that Decision No. 78800 is modified as follows:

1. Ordering paragraph 1 is deleted and the following ordering paragraph No. 1 substituted therefor:

"The Pacific Telephone and Telegraph Company shall provide optional measured extended area service from its Poway, Rancho Santa Fe and Del Mar exchanges to its San Diego exchange at reasonable compensatory rate levels for business and residential service and to make such service and rates effective not later than August 1, 1975."

2. Ordering paragraph 2 is deleted and the following ordering paragraph No. 2 substituted therefor:

"By not later than August 1, 1975, Pacific shall withdraw residence four-party line flat rate service in its Del Mar exchange and substitute therefor residence two-party line message rate 20-message allowance service at a rate of \$2.95 per month."

3. Ordering paragraph 3 is deleted and the following ordering paragraph No. 3 substituted therefor:

"By not later than December 31, 1972, Pacific shall present to this Commission a written plan for the orderly development of measured rate optional extended area telephone service for all of its exchanges not then having such service. All independent telephone companies in California which concur in the message toll telephone service rates of Pacific are invited to participate with Pacific in the preparation of this written plan. All such companies electing to participate shall notify Pacific and this Commission within 30 days of the effective date of this order."

IT IS FURTHER ORDERED that in all other respects the petitions of Pacific and Continental are hereby denied.

The Secretary is directed to serve copies of this order upon each toll concurring telephone company in California.

The effective date of this order shall be twenty days after the date hereof.
