In the Matter of the Application of GIBRALTAR WAREHOUSES, a corporation, for a certificate of public convenience and necessity authorizing the transportation of property between San Francisco, on the one hand, and, on the other, Milpitas, as an extension of present operations.

$\underline{O P I N I O N}$

Gibraltar Warehouses, presently engaged as a public utility warehouseman in the City and County of San Francisco, and as a highway common carrier in the transportation of general commodities between San Francisco, on the one hand, and points in the San Francisco Bay Area, on the other hand, requests authority to extend its highway common carrier service between San Francisco, on the one hand, and Milpitas, on the other hand.

Applicant owns and operates 26 units of equipment and, as of December 31, 1971, indicated a net worth in the amount of \$249,924. The proposed service would be daily and overnight. The proposed rates would be as provided in the Commission's Minimum Rate Tariff 2.

It is alleged that applicant is serving warehouse customers which distribute their goods from San Francisco; that during recent months a number of shippers applicant and its predecessors have served for many years in this manner have developed the need for service between San Francisco and Milpitas; that customers of those shippers have moved their plants to Milpitas from points presently served by applicant; that in order to continue to give its shippers at its warehouse the complete service which they have been receiving from applicant, that applicant needs to extend its service to Milpitas; and that applicant does not anticipate that the granting of the application will cause any diversion of traffic from other common carriers.

Copies of the application were served upon the existing carriers with which the proposed service might compete. No protest has been received.

After consideration the Commission finds that public convenience and necessity require the granting of the application. A public hearing is not necessary.

GIBRALTAR WAREHOUSES (a corporation)

First Revised Page 1 Cancels Original Page 1

Gibraltar Warehouses, a corporation, by the certificate of public convenience and necessity granted in the decision noted in the margin, is authorized to transport general commodities between:

- A. San Francisco, on the one hand, and Oakland, Emeryville, Berkeley, Alameda, San Leandro, Richmond, Albany, Union City, El Cerrito, Milpitas, and Fremont, on the other hand, in intrastate commerce.
- B. San Francisco, on the one hand, and Oakland, Emeryville, Berkeley, Alameda, San Leandro, Richmond, Albany, and El Cerrito, on the other hand, in interstate or foreign commerce.
- C. San Francisco, on the one hand, and points on U.S. Highway 101 between Daly City and San Jose, and points on U.S. Highway 101 By-Pass between Bayshore and San Jose, on the other hand, in intrastate, interstate or foreign commerce.

Applicant shall not transport any shipments of:

- Used household goods and personal effects not packed in accordance with the crated property requirements set forth in Item No. 5 of Minimum Rate Tariff No. 4-B.
- Automobiles, trucks and buses, viz.: new and used, finished or unfinished passenger automobiles (including jeeps), ambulances, hearses and taxis; freight automobiles, automobile chassis, trucks, truck chassis, truck trailers, trucks and trailers combined, buses and bus chassis.
- 3. Livestock, viz.: bucks, bulls, calves, cattle, cows, dairy cattle, ewes, goats, hogs, horses, kids, lambs, oxen, pigs, sheep, sheep camp outfits, sows, steers, stags or swine.
- 4. Commodities requiring the use of special refrigeration or temperature control in specially designed and constructed refrigerated equipment.
