 Movements shall be made in accordance with Rule 93.

In all other respects Decision No. 71908 dated January 24, 1967, as amended by Decision No. 73658, dated January 30, 1968, by Decision No. 75136, dated December 20, 1968, by Decision No. 77002, dated March 31, 1970, and by Decision No. 77677, dated September 1, 1970, shall remain in full force and effect.
