SUPPLEMENTAL OPINION AND ORDER

West Los Angeles Milling Co., a corporation, possesses prescriptive operative rights as a public utility warehouseman for the operation of storage or warehouse floor space at and in the vicinity of Chino, Durham and Sutter.

On March 9, 1972, West Los Angeles Milling Co. submitted to this Commission a Certificate of Amendment of Articles of Incorporation duly filed with the Secretary of the State of California indicating that the corporate name of the company was changed to Westlam Foods. Accordingly, the operative rights will be amended to show the new corporate name. A public hearing is not necessary.

IT IS ORDERED that:

- 1. The prescriptive operative rights as a public utility warehouseman possessed by West Los Angeles Milling Co., a corporation, and set forth in Appendix A of Decision No. 74132 in Application No. 46708, are amended by substituting therein "Westlam Foods" in place and stead of "West Los Angeles Milling Co."
- 2. Appendix A of Decision No. 74132 is hereby superseded by Appendix B attached hereto.

The Secretary is directed to cause service of a certified copy of this order to be made upon Westlam Foods or to mail a certified copy thereof to it at its last known address as shown in the Commission's records.

This order shall become effective twenty days after the date hereof.
