It is hereby found that the crossing protection described in Exhibit 43 herein complies with the intent of ordering paragraph 1 of Decision No. 79854 and of ordering paragraph 1 of this order.

It is hereby concluded that ordering paragraphs 1 and 2 of Decision No. 79854 should be modified as set forth below, and that ordering paragraph 5 should be stayed, and that such action will satisfy the contentions raised by Southern Pacific Transportation Company and The Atchison, Topeka and Santa Fe Railway Company in their respective petitions for rehearing and/or modification filed herein.

IT IS HEREBY ORDERED that:

1. Ordering paragraph 1 of Decision No. 79854 is hereby modified to read:

"1. Southern Pacific Transportation Company (Southern Pacific) shall modify the automatic protection at its Crossing No. B-48.9 to provide four automatic gate arms and Standard No. 8 signals with a control system designed in accordance with General Order No. 75-B and to minimize overactuation of signals and down time of gates."

2. Ordering paragraph 2 of Decision No. 79854 is hereby modified to read:

"2. The Atchison, Topeka and Santa Fe Railway Company (Santa Fe) shall modify the automatic protection at its Crossing No. 2-1155.7 to provide two automatic gate arms and Standard No. 8 signals with additional flashing light signals on cantilever arms with a control system designed in accordance with General Order No. 75-B and to minimize overactuation of signals and down time of gates."

3. The effect of ordering paragraph 5 of Decision No. 79854 shall be stayed until further order of the Commission.

4. The petitions of Southern Pacific Transportation Company and The Atchison, Topeka and Santa Fe Railway Company for rehearing or modification of Decision No. 79854 are hereby denied.

5. In all other aspects, Decision No. 79854 shall remain in full force and effect.
