ORDER REVOKING OPERATING AUTHORITY

County Transit Lines, Inc., was granted authority by Decision No. 72023, dated February 15, 1967, in Application No. 49081, which was amended by Decision No. 72796, dated July 25, 1967, in Application No. 49303 and by Decision No. 72905, dated August 15, 1967, in Application No. 49371, to conduct operations as a passenger stage corporation between various points in Contra Costa County.

Authority as described above was suspended for twelve months from February 16, 1970, by Decision No. 76713, dated January 27, 1970, as sought by the carrier in Application No. 51299. Ordering Paragraph Three of Decision No. 76713 provided that applicant's certificate would be revoked and its tariffs canceled on February 16, 1971, unless applicant applied to transfer its certificate or reestablished service prior to the deadline.

By Decision No. 73324, dated February 17, 1971, in Application No. 51299, applicant's operating authority was continued in suspension for another year to expire February 17, 1972. The carrier has not requested a transfer, has not filed evidence of insurance coverage pursuant to General Order No. 101-C, nor reestablished service.

It appears, and the Commission finds, that these matters constitute good cause for the revocation of the operating rights of the applicant.

The Commission, therefore, concludes that the Certificate of Public Convenience and Necessity to conduct operations of a passenger stage corporation granted to County Transit Lines, Inc., should be revoked.

IT IS ORDERED that:

- The Certificate of Public Convenience and Necessity to operate as a passenger stage corporation granted by Decision No. 72023, dated February 15, 1967, in Application No. 49081, as amended by Decision No.72796, dated July 25, 1967, in Application No. 49371 and by Decision No. 72905, dated August 16, 1967 in Application No. 49371, is hereby revoked.
- 2. All tariffs and timetables on file with the Commission and issued by or on behalf of County Transit Lines. Inc., are hereby canceled. A copy of this Order shall be filed with said tariffs in the office of the Commission.
