ORDER REVOKING OPERATING AUTHORITY

Ora B. Smith and Chester R. Smith, doing business as Santa Cruz Transit Company were granted a certificate of public convenience and necessity to conduct operations as a passenger stage corporation as defined in Section 226 of the Public Utilities Code by Decision No. 62133 dated June 13, 1961 in Application No. 32349 as amended by Decision No. 69137 dated May 25, 1965 in Application No. 46971, by Decision No. 71312 dated September 20, 1966 in Application No. 48773 and by Decision No. 73883 dated March 19, 1968 in Application No. 49982.

The Commission has received information that the Santa Cruz Metropolitan Transit District now conducts operations in the territory previously served by the Santa Cruz Transit Company, except for on-call service provided between Santa Cruz, Capitola and Scotts Valley, on the one hand, and Candlestick Park in the City and County of San Francisco, on the other hand.

Santa Cruz Transit Company has discontinued service on all but the Candlestick Park route.

It appears and the Commission finds that these matters constitute good cause for the revocation of the operating authority of Santa Cruz Transit Company except for the authority to operate to Candlestick Park.

The Commission, therefore, concludes that the authority of Santa Cruz Transit Company mentioned above should be revoked.

O R D E R

IT IS ORDERED that:


1. The certificate of public convenience and necessity granted to Ora B. Smith and Chester R. Smith to operate as a passenger stage corporation, as that term is defined in Section 226 of the Public Utilities Code is hereby modified and Appendix A to Decision No. 62133 in Application No. 43459 is amended by incorporating therein First Revised Page 5, Second Revised Pages 1, 3 and 4, Third Revised Page 2 attached hereto, as replacement for First Revised Pages 1, 3 and 4, and Second Revised Page 2 and Original Page 5.

2. In providing service pursuant to the certificate herein modified, applicant shall comply with and observe the following service regulations:


- a. Within thirty days after the effective date hereof, applicants shall file a written acceptance of the certificate herein granted.
- b. Within one hundred twenty days after the effective date hereof, applicant shall amend or reissue tariffs and timetables on file in the Commission's office.
- c. The tariff and timetable filings shall be made effective not earlier than ten days after the effective date of this order on not less than ten days' notice to the Commission and to the public.
- d. The tariff and timetable filings made pursuant to this order shall comply with the regulations governing the construction and filing of tariffs and timetables set forth in the Commission's General Orders Nos. 79 and 98.

The effective date of this order shall be twenty days after the date hereof.

SECTION 1. General Authorizations, Restrictions,
Limitations and Specifications.

Ora B. Smith and Chester R. Smith, by the certificate of public convenience and necessity granted by the decision noted in the margin, are authorized to transport passengers between Santa Cruz, Capitola and Scotts Valley, on the one hand, and Candlestick Park in the City and County of San Francisco, on the other hand, over and along the routes hereinafter described, subject to the following provisions:

- (a) Motor vehicles may be turned at termini and intermediate points, in either direction, at intersections of streets or by operating around a block contiguous to such intersections, in accordance with local traffic regulations.
- (2) Candlestick Park service shall be rendered on a round-trip "on-call" basis for any and all sporting events on the demand of 20 or more passengers
