Appendix A

1. Whether public health and safety require either the reconstruction, relocation, alteration of said crossing, the installation of additional protective devices, the alteration of existing protective devices or any combination of the above, pursuant to Section 1202 of the Public Utilities Code.

2. Whether public health and safety may require the physical closing of said crossing or closing of use thereof by the public pursuant to Section 1202 of the Public Utilities Code.

3. The terms upon which any such reconstruction, relocation, alteration, abolition, or installation shall be accomplished, including apportionment of costs among all respondents, or any of them, as appears just and reasonable, pursuant to Section 1202 of the Public Utilities Code.

4. The terms upon which any costs of maintenance shall be apportioned pursuant to Section 1202.2 of the Public Utilities Code.

5. Whether any other order or orders shall be issued by the Commission in the lawful exercise of its jurisdiction.
