ORDER REVOKING CERTIFICATE AUTHORITY

By Decision No. 58060 dated March 2, 1959, in  
 Application No. 40794, J. Ned Richardson, Robert Richardson and  
 Richardson Cattle and Land Development Company, a corporation dba  
 Richardson Springs Stage, was granted a Certificate of Public  
 Convenience and Necessity to operate as a passenger stage  
 corporation between Richardson Springs and Chico, with Chico  
 Municipal Airport as an intermediate point.

Since June 20, 1971, the above carrier, dba Richardson  
 Springs Stage, has had no evidence on file with this Commission  
 showing adequate protection against liability imposed by law for  
 payment of damage for personal injury or property damage, as  
 required by General Order No. 101-C. Richardson Springs Stage  
 Line has discontinued its service and ceased operations as stated  
 in its letter to the Commission, received March 30, 1972.




IT IS ORDERED that the Certificate of Public Convenience  
 and Necessity to operate as a passenger stage corporation between  
 Richardson Springs and Chico authorized by Decision No. 58060 in

Application No. 40794 is hereby revoked and all effective tariffs and timetables on file with the Commission in the name of J. Ned Richardson, Robert L. Richardson and Richardson Cattle and Land Development Company are canceled upon the effective date of this order.

The Secretary is directed to mail a certified copy of this order to Richardson Springs Stage, P. O. Box 911 at Chico, California 95926, last known address as shown on the Commission's records.

The effective date of this order shall be 20 days after the mailing of said order, unless before such effective date there shall have been filed with the Commission written response to this order requesting public hearing, in which event the effective date of this order shall be stayed until further order of the Commission.
