## SUPPLEMENTAL OPINION AND ORDER

James R. Mullens, Howard W. Hester and Bernard J. Glaser, doing business as a partnership under the fictitious name of Action Drayage Co., by Decision No. 79857, dated March 28, 1972, in Application No. 53096, were granted a certificate of public convenience and necessity authorizing operations as a highway common carrier, as defined in Section 213 of the Public Utilities Code, between points and places in the San Francisco Territory and over routes particularly set forth in Appendices A and B attached thereto and made a part of Decision No. 79857. A certain highway designation referred to in this decision was inadvertently misdescribed.

In the circumstances, it appears, and the Commission finds, that the necessary change should be made by the order herein. A public hearing is not necessary. The Commission concludes that Appendix A of Decision No. 79857, supra, should be amended accordingly.

IT IS ORDERED that Decision No. 79857 is hereby amended by substituting the attached First Revised Page 1 of Appendix A in the place and stead of the present Original Page 1 of Appendix A.

The effective date of this order shall be the date hereof.

James R. Mullens, Howard W. Hester and Bernard J. Glaser, individuals, doing business as Action Drayage Co., by the certificate of public convenience and necessity granted by the decision noted in the margin, are authorized to conduct operations as a highway common carrier as defined by Section 213 of the Public Utilities Code for the transportation of general commodities as follows:

- 1. BETWEEN all points and places in the San Francisco Territory as described in Appendix B.
- BETWEEN all points on or within five miles of the following routes;
  - a. State Highway 24 between its intersection with Interstate Highway 80 and its intersection with Interstate Highway 580, inclusive;
  - b. Interstate Highway 680 between its intersection with State Highway 24 at Walnut Creek and its intersection with State Highway 24 below Willow Pass Road, inclusive;
  - c. State Highway 24 between its intersection with Interstate Highway 680 below Willow Pass Road and its intersection with Willow Pass Road to Concord, inclusive;
  - d. State Highway 24 between its intersection with Interstate Highway 680 below Willow Pass Road and its intersection with Concord Avenue to Concord, inclusive;
  - e. Interstate Highway 680 between its intersection with State Highway 24 at Walnut Creek and its intersection with U.S. Highway 50, inclusive:
  - f. U.S. Highway 50 between its intersection with Interstate Highway 680 and its intersection with State Highway 17, inclusive;
  - g. Interstate Highway 680 between its intersection with U.S. Highway 50 and its intersection with Bernal Avenue, inclusive.
