ORDER MODIFYING DECISION

Following the issuance of Decision No. 80090 on May 18, 1972, under the above-entitled application, an error was discovered in the preparation of the revised rate schedules attached to that order as Appendix A. The rate levels presently specified will fall short of producing the gross revenues to provide the authorized rate of return by approximately \$19,900 annually. The revised rate schedules attached to this order will correct this error; therefore,

IT IS ORDERED that:

After the effective date of this order California Water Service Company is authorized to file the revised rate schedules attached to this order as Appendix A. Such filing shall comply with General Order No. 96-A. The effective date of the revised schedules shall be four days after the date of filing. The revised schedules shall apply only to service rendered on and after the effective date thereof.
