SECOND SUPPLEMENTAL OPINION AND ORDER

Decision No. 80147 in this proceeding provided for the revocation of the highway common carrier authority of Carl P. Kreifels on July 14, 1972 unless prior thereto, the carrier complied with the requirements of Section 486 of the Public Utilities Code or filed a request to suspend his operations.

The carrier responded with a request to suspend his operating authority until March 14, 1973. This period of suspension is requested to enable a sale and transfer of the certificate.

After consideration, the Commission finds that the proposed period of suspension of service would not be adverse to the public interest and concludes that it should be granted. A public hearing is not necessary.

IT IS ORDERED that:

1. The certificate of public convenience and necessity to operate as a highway common carrier acquired by Carl P. Kreifels pursuant to Decision No. 45499, dated March 27, 1951, as amended by Decision No. 45647, dated May 1, 1951, in Application No. 30449 is hereby suspended.

2. During the period of suspension, Carl P. Kreifels, an individual, doing business as Geneva Transfer and Drayage Co., shall continue to file annual report, quarterly reports and pay fees pursuant to Section 5003.1 of the Public Utilities Code.

3. Prior to the expiration date of the suspension period or the date service is resumed when the latter date is earlier than said expiration date, Carl P. Kreifels, an individual, doing business as Geneva Transfer and Drayage Co., shall file a list of motor equipment to be operated and file and have in effect evidence of adequate liability insurance protection in compliance with Commission General Order No. 100-Series.

4. Tariff schedules naming rates and rules governing the common carrier operations herein shall be brought up to date in compliance with all applicable Commission minimum rate orders. The required tariff filings shall be made effective on not less than ten days' notice to the Commission and to the public and the effective date of the tariff filings shall be concurrent with the expiration date of the suspension period or the date when service is resumed when the latter date is prior to said expiration date.

5. Carl P. Kreifels, an individual, doing business as Geneva Transfer and Drayage Co., is placed on notice that commencement of operations under the certificate referred in Ordering Paragraph 1 herein, prior to compliance with Ordering Paragraphs 2, 3 and 4, may be cause for further suspension or revocation of the operating authority of Carl P. Kreifels, an individual, doing business as Geneva Transfer and Drayage Co.

6. The authority to suspend operations granted herein shall expire on March 14, 1973, or upon earlier resumption of operations which may be effected upon compliance with Ordering Paragraphs 2, 3 and 4.

7. Carl P. Kreifels, an individual, doing business as Geneva Transfer and Drayage Co., is placed on notice that the operating authority granted by the certificate of public convenience and necessity in Decision No. 45499, dated March 27, 1951, as amended by Decision No. 45647, dated May 1, 1951, in Application No. 30449, is hereby revoked effective March 14, 1973 unless on or before such date compliance with Ordering Paragraphs 2, 3 and 4 is effected.

The Secretary is directed to cause service of this order to be made by certified mail upon Carl P. Kreifels.

The effective date of this order shall be the date hereof.
