Application of Henderson Center Cab Company, a corporation, doing business as Yellow Cab Co., to operate a Passenger Stage Corporation between Eureka, Arcata, Eureka-Arcata Airport on an on-call basis.

# OPINION

Henderson Center Cab Company, a corporation, doing business as Yellow Cab Co. and presently operating a passenger stage service between Eureka, on the one hand, and College of the Redwoods and Ferndale, on the other hand, requests authority to extend service between Eureka and Arcata, on the one hand, and the Eureka-Arcata Airport located at McKinleyville, on the other hand.

The service would be on-call. Calls would have to be placed one and one-half hours before scheduled flight departure. The proposed fares are \$3 between Eureka and the airport and \$2 between Arcata and the airport. As of April 30, 1972, applicant indicated a net worth in the amount of \$27,497.

It is alleged that applicant has been operating taxis in the Eureka area and has been offering cab service at the airport.

Copies of the application were served upon Western Greyhound Lines, Yreka Western Railroad, Eureka Chamber of Commerce, the City of Eureka, City of Arcata, Humboldt County Supervisors, and the Humboldt County Chamber of Commerce. No protest has been received.

After consideration the Commission finds that public convenience and necessity require the granting of the application. A public hearing is not necessary. The application will be granted by restating applicant's operating authority in the form of a new certificate.

- (c) The tariff and timetable filings shall be made effective not earlier than ten days after the effective date of this order on not less than ten days' notice to the Commission and the public, and the effective date of the tariff and timetable filings shall be concurrent with the establishment of the service herein authorized.
- (d) The tariff and timetable filings made pursuant to this order shall comply with the regulations governing the construction and filing of tariffs and timetables set forth in the Commission's General Orders Nos. 79 and 98-A.
- (e) Applicant shall maintain its accounting records on a calendar year basis in conformance with the applicable Uniform System of Accounts or Chart of Accounts as prescribed or adopted by this Commission and shall file with the Commission, on or before March 31 of each year, an annual report of its operations in such form, content, and number of copies as the Commission, from time to time, shall prescribe.
- 3. The certificate of public convenience and necessity granted in paragraph 1 of this order shall supersede the certificate of public convenience and necessity granted by Decision No. 76548, dated December 16, 1969, in Application No. 51287, which certificate is revoked effective concurrently with the effective date of the tariff filings required by paragraph 2(b) hereof.

The effective date of this order shall be five days after the date hereof.

# YELLOW CAB COMPANY

SECTION 1. GENERAL AUTHORIZATIONS, RESTRICTIONS, LIMITATIONS AND SPECIFICATIONS.

Henderson Center Cab Company by the certificate of public convenience and necessity granted is authorized to transport passengers and their baggage on an "on-call" basis, over and along the routes hereinafter described, subject, however, to the authority of this Commission to change or modify said routes at any time and subject to the following provisions:

- (a) Motor vehicles may be turned at termini and intermediate points, in either direction, at intersections of streets or by operating around a block contiguous to such intersections, in accordance with local traffic regulations.
- (b) When route descriptions are given in one direction, they apply to operation in either direction unless otherwise indicated.
- (c) Route 1 and Route 2 are subject to a minimum of six (6) passengers in order to run a schedule.
- (d) Direct service between Ferndale and the College of the Redwoods located at Beatrice is not authorized.
- (e) Service on Route 1 shall be operated only on those days when the college is in session.
- (f) Service on Route 3 shall be subject to call one and one-half (1½) hours before scheduled flight departure and service must be requested after flight arrival.
- (g) The tariffs and timetables shall show the conditions under which each authorized "on-call" service will be rendered.

#### SECTION 2. ROUTE DESCRIPTIONS.

Route 1. Eureka - College of the Redwoods located at Beatrice

Between Eureka on the one hand, and the College of the Redwoods located at Beatrice on the other hand over the following route: Over appropriate city streets of the City of Eureka to Highway 101, south on Highway 101 to Tompkins Hill Road, southeast on Tompkins Hill Road to the College of the Redwoods. Return route, northwest on Tompkins Hill Road to Highway 101, north on Highway 101 to the City of Eureka, over appropriate city streets of the City of Eureka to station.

## Route 2. Eureka - Ferndale

Between Eureka on the one hand, and Ferndale located 19 miles southwest of Eureka on the other hand over the following route: Over appropriate city streets of the City of Eureka to Highway 101, south on Highway 101 to Fernbridge then southwest on Highway 1 to Fernbridge, north on Highway 101 to the City of Eureka, over appropriate city streets to the City of Eureka to station.

Route 3. Eureka, Arcata - Eureka-Arcata Airport located at McKinley

Commencing at Eureka Inn located at Seventh and "F" Streets in the City of Eureka; thence via Seventh Street, "I" Street, Fifth Street, U.S. Highway 101 to Samoa Boulevard in the City of Arcata; thence via Samoa Boulevard, "G" Street to Ninth Street (Arcata Passenger Stop); thence via "G" Street, Seventeenth Street, U.S. Highway 101, Airport Boulevard, County Road to Eureka-Arcata Airport at McKinleyville.
