ORDER DENYING REHEARING

Petitions for rehearing of Decision No. 80235 having been filed by California Manufacturer's Association, the National Small Shipments Traffic Conference, Inc., and Drug and Toilet Preparation Traffic Conference, the Commission having considered said petitions, and each and every allegation thereof, and being of the opinion that no good cause for rehearing has been shown,

2. Minimum Rate Tariff 2 (Appendix D to Decision No. 31606, as amended) is hereby further amended by incorporating therein to become effective August 25, 1972, vacating Supplement 93 attached hereto and by this reference made a part hereof.

3. Minimum Rate Tariff 2 (Appendix D to Decision No. 31606, as amended) is further amended by reincorporating therein Second Revised Page 42-C, Thirtieth Revised Page 43, Thirtieth Revised Page 43-A, Thirty-eighth Revised Page 44, Nineteenth Revised Page 44-A and Twenty-sixth Revised Page 44-B, to become effective August 25, 1972.

4. Except for the note on Third Revised Page 42-C and Thirty-first Revised Page 43, Notes 4 on Thirty-first Revised Page 43-A, Thirty-ninth Revised Page 44 and Twentieth Revised Page 44-A and Note 2 on Twenty-seventh Revised Page 44-B, the rates and other provisions as set forth on said pages are hereby canceled effective August 25, 1972.

5. Tariff publications of common carriers may be made effective on one day's notice to the Commission and to the public.
