## ORDER MODIFYING AUTHORITY

In Exhibit No. 3 of Application No. 49781 by Borrego Springs Airline (BSA), the carrier proposed no service between San Diego and Borrego Springs from June 16 through the month of September, each year.

By Decision No. 75558 dated April 15, 1969, BSA was granted the authority to serve between San Diego and Borrego Springs. Finding No. 5 in the decision stated that:

> "Borrego Springs Airline presently can economically give adequate service to the communities involved while flying the minimum schedules proposed".

It is noted, however, that Appendix A of Decision No. 75558 did not reflect any condition that the carrier could discontinue service June through September, as discussed in the applicant's proposal and the Commission's findings.

Two other considerations should be noted. First, every other route granted to BSA has the condition that the corrier may discontinue operations during the months of June through September. Second, the carrier is presently not scheduling service between San Diego and Borrego Springs during these months.

Therefore, the Commission concludes that it is now appropriate to modify Borrego Springs Airline's Certificate of Public Convenience and Necessity so as to reflect the carrier's original proposal and its subsequent actual operations. A public hearing is not necessary.

- 2. Borrego Springs (San Diego County Airport) Palm Springs Municipal Airport.
- 3. San Diego International Airport (Lindbergh Field) -Palm Springs Municipal Airport.

### Conditions

- #1. Service on Route 1 may be discontinued during the months of June, July, August and September.
  - Minimum service on each of Routes 2 and 3 shall be not less than three round trips per week, except that service may be discontinued during the months of June, July, August and September.
  - 3. No aircraft having more than 25 revenue passenger seats shall be operated.
