SUPPLEMENTAL OPINION AND ORDER

Santa Monica Lease, Inc. possesses a certificate of public convenience and necessity to operate as a public utility warehouseman for the operation of storage or warehouse floor space at Los Angeles and Vernon.

Santa Monica Lease, Inc. has submitted to this Commission a copy of its Certificate of Amendment of Articles of Incorporation, certified by the Secretary of State, indicating that its corporate name has been changed to Union Terminal Warehouse, Inc. Accordingly, its certificate will be amended to show the new corporate name and the warehouseman will be ordered to amend its tariffs on file with the Commission pursuant to General Order No. 61-A. A public hearing is not necessary.

IT IS ORDERED that:

1. The certificate of public convenience and necessity granted to Santa Monica Lease, Inc. by Decision No. 80669 dated October 31, 1972, in Application No. 53486, is amended by substituting therein "Union Terminal Warehouse, Inc." in place and stead of "Santa Monica Lease, Inc."


2. Appendix A of Decision No. 80669 is amended by incorporating therein First Revised Page 1, attached hereto, in revision of Original Page 1.


3. Within one hundred and twenty days after the effective date hereof and on not less than ten days' notice to the Commission and to the public, Union Terminal Warehouse, Inc. shall amend its tariffs on file with this Commission as required by Rule 6.2 of General Order No. 61-A.


