ORDER OF REVOCATION

Live Stock Transport Co., a California corporation, is the owner and holder of a certificate of public convenience and necessity issued by this Commission in Decision No. 52422, dated December 28, 1955, in Application No. 35979, as transferred to Live Stock by Decision No. 58799, dated July 28, 1959, in Application No. 41190. Said certificate authorizes the transportation of livestock between points and places in the State of California and was suspended for a period of one year until September 1, 1971, by Decision No. 77621, in Application No. 52017, and was further suspended for an additional year until September 1, 1972, by Decision No. 79150, in Application No. 52795.

Applicant, pursuant to the provisions of Section 1070 of the Public Utilities Code, seeks authority to terminate all highway common carrier operations and for revocation of its certificate of public convenience and necessity.

Applicant alleges that its reasons for proposing to terminate all of its highway common carrier operations and for revocation of its certificate, are the same as set forth in Applications Nos. 52017 and 52795 for suspension and that Mr. John Shubin, Jr., President and sole shareholder of Live Stock,


continues to be ill and is unable to devote the time and attention required to properly manage the operations of the business and that he has been advised by his physician to reduce the scope of his business activities in the interest of his health. That final termination of highway common carrier operations by the applicant will have little or no effect upon the shipping public.


After consideration the Commission finds that public convenience and necessity no longer requires a continuation of applicant's service. No protest has been received, applicant's service has been suspended for more than two years under Decisions Nos. 77621 and 79150. A public hearing is not necessary.


IT IS ORDERED that the certificate of public convenience and necessity issued to Live Stock Transport Co., a California corporation, to transport livestock between points and places within the State of California as authorized by Decision No. 52422, dated December 28, 1955, in Application No. 35979 is hereby revoked and all tariff filings thereunder are canceled.


The effective date of this order shall be twenty days after the date hereof.
