ORDER OF REVOCATION

By Decision No. 74248, dated June 11, 1968, in Application No. 50072, Air California was granted a certificate of public convenience and necessity to operate as a passenger air carrier between San Jose Municipal Airport and Oakland International Airport on the one hand and Hollywood-Burbank Airport on the other.

By Decision No. 76780, dated February 10, 1970, in Application No. 51610, Air California was granted permission permanently to discontinue operations on routes serving Hollywood-Burbank Airport. Those operations were discontinued on or about January 21, 1970, and have not been resumed.

The Commission finds that after receiving authority, Air California operated on routes serving Hollywood-Burbank Airport; that it discontinued such operations in January 1970; that it has not resumed such operations since that time; and that the certificate of public convenience and necessity of Air California shows Hollywood-Burbank Airport as a point on various of its routes. The Commission concludes that Hollywood-Burbank Airport should be deleted as a point on routes in Air California's certificate of public convenience and necessity.

IT IS ORDERED that reference to Hollywood-Burbank Airport be deleted from the certificate of public convenience and necessity of Air California and that its certificate of public convenience and necessity be revised as set forth in First Revised Page 1, First Revised Page 4, and First Revised Page 5 of Appendix A of Decision No. 80439 attached hereto.

The authority stated herein to Air California supersedes all previously granted certificates of public convenience and necessity.

Air California is authorized to operate over the routes described as follows:

- Route 1 Between Orange County Airport, on the one hand, and San Jose Municipal Airport, Oakland International Airport and San Francisco International Airport, on the other hand, with each of the last three named airports being either a terminal or intermediate point for this route.
- #Route 2 Between Orange County Airport and Ontario International Airport, on the one hand, and San Jose Municipal Airport and Oakland International Airport, on the other hand, with each of the first two named airports and each of the last two airports, respectively, being either a terminal or intermediate point for this route.
- Route 3 Nonstop service between San Diego International Airport and San Jose Municipal Airport.
- Route 4 Between San Diego International Airport, on the one hand, and San Jose Mumicipal Airport and Oakland International Airport, on the other hand, via the intermediate point of Orange County Airport, with San Jose Mumicipal Airport and Oakland International Airport being either a terminal or intermediate point for this route.
