## ORDER OF REVOCATION

By Decision No. 52915 dated April 17, 1956, in Application No. 37728 and as amended by Decision No. 62928 dated December 12, 1961 in Application No. 42919 and Decision No. 68503 dated January 19, 1965 in Application No. 46727 and Decision No. 73633 dated January 16, 1968 in Application No. 49799 and Decision No. 74932 dated November 13, 1968 in Application No. 50562, San Jose City Lines was granted a Certificate of Public Convenience and Necessity to operate as a passenger stage corporation between points in the Cities of San Jose and Santa Clara and areas adjacent thereto.

A letter requesting revocation of the Certificate of Public Convenience and Necessity of San Jose City Lines has been received from Mr. James E. Gallagher, attorney for the carrier. He stated "the Santa Clara County Transit District, a body politic, purchased all of the real estate, improvements, fixtures, rolling stock supplies, inventory, et cetera, and that the said Transit District since January 1, 1973 has been in full operation of transit services in Santa Clara County."

On January 1, 1973, San Jose City Lines abandoned service and ceased operations. Santa Clara County Transit District time-tables show an immediate assumption of the operation of this service.

It appears and the Commission finds that these matters constitute good cause for the revocation of the aforenamed certificate and that such revocation would not be adverse to the public interest. The Commission, therefore, concludes that the certificate

should be revoked and that tariffs and timetables applicable to the service thereunder should be canceled.

IT IS ORDERED that the Certificate of Public Convenience and Necessity of San Jose City Lines to operate as a passenger stage corporation authorized by Decision No. 52915 in Application No. 37728 and as amended is hereby revoked and all effective tariffs and timetables on file with the Commission in the name of San Jose City Lines are canceled upon the effective date of this order.

The Secretary is directed to mail a certified copy of this order to San Jose City Lines at 860 West San Carlos, San Jose, CA 95126, Santa Clara County Transit District, 70 West Hedding Street, San Jose, CA 95110 and Mr. James E. Gallagher, 1417 Central Bldg., 436 - 14th Street, Oakland, CA 94612.

The effective date of this order shall be thirty days after the above mailing to San Jose City Lines, Santa Clara County Transit District and Mr. Gallagher unless before such effective date there shall have been filed with the Commission written response to this order requesting public hearing in which event the effective date of this order shall be stayed until further order of the Commission.
