SUPPLEMENTAL OPINION AND ORDER

It has come to the Commission's attention that the suspended surcharge provisions of Supplement 38 to Minimum Rate Tariff 7, which were vacated effective March 5, 1973, by Decision No. 81081 in these proceedings, do not reflect the intent of Decision No. 80481.

In the circumstances, the Commission finds that the necessary corrections should be made by the order herein. A public hearing is not necessary. The Commission concludes that Minimum Rate Tariff 7 should be amended accordingly.

IT IS ORDERED that Minimum Rate Tariff 7 (Appendix A of Decision No. 32566, as amended) is hereby amended by incorporating therein to become effective March 13, 1973, Supplement 42

attached hereto and by this reference made a part hereof.

In all other respects, Decision No. 32566, as amended, shall remain in full force and effect.

APPLICATION OF SURCHARGE

Compute the amount of charges in accordance with the rates and charges in Items 127, 130, 138, 138.1, 148, 148.1, 150, 150.1, 294, 294.3 and 294.6 and increase the amount so computed by ten (10) percent dropping fractions of less than one-half cent and increasing fractions of one-half cent or greater to one cent.

(2) Compute the amount of charges in accordance with the rates and charges in Items 360, 361 and 365 and increase the amount so computed by five and one-half (5½) percent dropping fractions of less than one-half cent and increasing fractions of one-half cent or greater to one cent.
