On February 14, August 9, and December 27, 1972 petitioners were requested by letter to advise the Commission as to when they would be prepared to go to hearing in this matter. On the latter date petitioners were advised that unless they were "now in a position to suggest, by return mail, a specific and mutuelly agreeable series of hearing dates in this matter, the Commission will be advised to terminate its order granting rehearing in Decision No. 79655 for want of prosecution."

Petitioners have resisted all efforts during the past year to set a date for the partial rehearing of Decision No. 79351 as ordered by the Commission. It is petitioners' contention that, until the Interstate Commerce Commission issues its decision in related ICC Docket No. 35498, no useful purpose would be served by now setting a date for the partial rehearing of this Commission's Decision No. 79351.

Petitioners advice that ICC Docket No. 35498 was submitted for decision on August 2, 1972. When a decision will be issued is unknown. Under the circumstances, further retention of an order on this Commission's open docket granting partial rehearing of Decision No. 79351 is no longer justified. The order should be rescinded and the related petitions for rehearing dismissed without prejudice.

IT IS ORDERED that the Commission's order in Decision No. 79656 granting partial rehearing of Decision No. 79351 is rescinded
