ORDER OF REVOCATION

By Decision No. 62897 dated December 5, 1961 in Application No. 43672, as amended by Decisions Nos. 65293 and 65431 dated May 1, 1963 and May 21, 1963, respectively, in Application No. 45243 V. M. McDonald and J. D. Hansen dba San Pedro Transit Lines were granted a Certificate of Public Convenience and Necessity to operate as a passenger stage corporation between the San Pedro and the Harbor City Districts of the City of Los Angeles and intermediate points.

V. M. McDonald and J. D. Hansen have expressed their desire to discontinue service because effective April 1, 1973 all operations of the San Pedro-Harbor City Line now operated by San Pedro Transit Lines will be assumed by the Southern California Rapid Transit District, with no change to the public in fare, schedule or route.

It appears and the Commission finds that these matters constitute good cause for the revocation of this certificate and

that such revocation would not be adverse to the public interest. The Commission concludes that the certificate should be revoked and that tariffs and timetables applicable to the service should be canceled.

IT IS ORDERED that the Certificate of Public Convenience and Necessity to operate as a passenger stage corporation authorized by Decision No. 62897 in Application No. 43672 as amended by Decisions Nos. 65293 and 65431 in Application No. 45243 is hereby revoked and all effective tariffs and timetables on file with the Commission in the name of San Pedro Transit Lines are canceled.
