SUPPLEMENTAL OPINION AND ORDER

Central Terminal Warehouse Company, a corporation, possesses a certificate of public convenience and necessity to operate as a public utility warehouseman for the operation of storage or warehouse floor space at Santa Fe Springs.

Central Terminal Warehouse Company, a corporation, has submitted to this Commission a copy of its Certificate of Amendment of Articles of Incorporation, certified by the Secretary of State, indicating that its corporate name has been changed to Central Terminal Warehouse & Trucking Co. Accordingly, its certificate will be amended to show the new corporate name. The warehouseman has amended its tariffs on file with the Commission pursuant to General Order No. 61-A. A public hearing is not necessary.

IT IS ORDERED that:

1. The certificate of public convenience and necessity granted to Central Terminal Warehouse Company, a corporation, by Decision No. 79855 dated March 28, 1972, in Application No. 53098 is amended by substituting therein "Central Terminal Warehouse & Trucking Co." in place and stead of "Central Terminal Warehouse Company."



